C. Approve March Minutes Regular Meeting

II. Academic and Family Life Committee

A. Committee Update

Ms. Russo updated the Board on the Academic and Family Life committee meeting; the school completed its lottery earlier this month and is actively enrolling students in all grades 2-9.

Principal Blough attended a session at St. Thomas Aquinas College, where he met former BSNBCS students enrolled there. The session was facilitated by Vice Chair Nesbitt, and we strengthened our relationship with the college.

The Board discussed the science education program related to the recent partial solar eclipse, which students and staff participated here in NYC.

The School continues to prepare students for the upcoming NYS 3-8 Exams in Science, ELA and Mathematics. The Board and staff discussed the nature of the Computer Based Testing framework, which is the first time the school participated in this new program.

Ms. Russo and Principal Blough discussed the upcoming visit of educators from Beijing to the school tomorrow. We look forward to the cultural exchange and sharing our school community with these international educators.

III. Governance Committee

A. Committee Update

We are registered for Boardlead, and is pursuing additional candidates for new trustees.

Tuesday, June 18th is the new is the June Meeting. Our retreat is on July 10th, 2024.

The Board discussed the upcoming meeting on May 14th to discuss the FY25 Budget and other financial matters.

The Trustees acknowledged the passing of Treasurer Shawn Carson's mother, as an extended member of the school community and a long time Bedford Stuyvesant resident.

IV. Finance Committee

A. Finance Committee Update

Chief Finance Officer Lisa-Renee Brown discussed the school's current financial position from our finance committee call. We are fully enrolled at 729 students and 156 students with disabilities. We had no extraordinary expenses and our finances are otherwise in order.

Ms. Brown discussed the school's efforts to support members of the community experiencing loss, with the school's provision of a grief counselor for all interested staff. Interest was triple the initial allocation, and the school continues to work closely with needs of our staff, to support their mental and physical health, as well as our retention of staff.

B. Presentation of Draft FY25 Budget

Mr. Tishuk presented the FY25 draft budget, describing the anticipated Income and Revenues as of the current time period. He answered questions from Trustees regarding the assumptions that will be shared in the May Board meetings.

C. Financial Policies and Procedures

The Board is required to review any changes of the Financial Policies and Procedures document. Trustees reviewed the document and voted to approve the new document. Doris Givens made a motion to approve the updated Financial Policies and Procedures document.

- 1. Per CAO Ms. Brown-both K-8 and High School principal report to her for academics.
- 2. Q-2 evaluation of staff has been completed. Those in good standing with qualifications and willing to improve are being mentored and will likely be asked back in addition to those with good academic standing at end of Q-2 evaluations. Hiring 8 possible positions for K-8.

 Non-returning teachers are due to not being asked back, moving up in the school or not returning on their own.
- 3. High School recruiting is going well and looks good to meet the 135 for September. Currently 65 BSNBCS going to our High School. Outreach is being done by dropping off recruitment packages and visits to other charter schools Subjects: English, Math. Science. Social Studies, Language, Music, Art and Careers e.g. computers and coding.
 NYS is designating all new Special Educations certs as K-12. Cert coincide with Masters' Degrees but there are no years of teaching requirements. The

with Masters' Degrees but there are no years of teaching requirements. The same teaching assistant designations and other non-teacher of record and non-core content teacher rules and flexibilities apply.

Graduation for 8th Graders is Saturday, June 15th at Bishop Loughlin Memorial HS.

- 4. Grades 3-7 Students were prepared for this week's NYS Math test and are looking forward to ELA test, May 14 and 15.
- 5. High schools our 8th graders will attend in September is in packet. 4 are accepted to a specialized high school. This is as of May 9th.
 - Recruitment conducted by Julissa to NYCHA building; visits to community day care centers; brochures to community businesses;5/18 a community event at 303 Vernon Ave
- 6. Everyone should look at the pictures of the Beijing visit. They visited schools in Chicago, Cleveland, Boston, New Jersey. Some locals were Midwood High School, Brooklyn Tech.

Even visited Yale University!

RESOLUTIONS OF THE BOARD OF TRUSTEES APPROVING CERTAIN REAL ESTATE TRANSACTIONS

May 15, 2024

The Board of Trustees (the "**Board**") of Bedford Stuyvesant New Beginnings Charter School, a New York not-for-profit education corporation (the "**School**") does hereby adopt the following resolutions at a duly held and noticed meeting on the date set forth above.

I. Lease Assignment and Sublease for 82 Lewis Avenue, Brooklyn, NY

WHEREAS, the School is a tenant at the facility located at 82 Lewis Avenue, Brooklyn, New York (the "Lewis Ave Premises") pursuant to that certain Lease dated as of September 1, 2010 (the "Lewis Ave Lease") by and between The Roman Catholic Church of St. John the Baptist, in the Borough of Brooklyn, in the City of New York ("Lewis Ave Landlord") and the School; and

WHEREAS, in conjunction with Friends of Bedford Stuyvesant New Beginnings Charter School, Inc. ("Friends"), in order to meet the School's long-term real estate needs and for strategic purposes, the Board has determined it is in the best interest of the School to assign the Lewis Ave Lease to Friends pursuant to an assignment and amendment of lease agreement (the "Assignment"), whereby Friends will assume the School's obligations under the Lewis Ave Lease and sublease the Lewis Ave Premises back to the School; and

WHEREAS, the School desires to sublease the Lewis Ave Premises from Friends pursuant to a sublease (the "Lewis Ave Sublease"), as more fully set forth in the Lewis Ave Sublease; and

WHEREAS, under the terms of the Assignment, as a material inducement to the Lewis Ave Landlord to approve the Assignment and Sublease, the School is required to guaranty the payment of rent and other expenses set forth in the Lewis Ave Lease, pursuant to a guaranty of lease (the "Guaranty"), and the School desires to issue the Guaranty to satisfy the Lewis Ave Landlord's requirements; and

WHEREAS, subject to additional minor additions and changes (the "Minor Modifications") to be made to the Assignment, Lewis Ave Sublease and the Guaranty through negotiations between the Lewis Ave Landlord and the Lewis Ave Landlord's legal counsel and the School's Proper Representatives (defined herein) and the School's and Friends' legal counsel, as applicable, the School wishes to enter into the Assignment, the Lewis Ave Sublease and the Guaranty for the Lewis Ave Premises so that Friends can enter into the Lewis Ave Lease for the Lewis Ave Premises;

II. Sublease for 217 North 10th Street, Brooklyn, NY

WHEREAS, Friends is the tenant pursuant to that certain Lease dated December 22, 2023 (the "N 10th Street Lease") by and between 215 N 10 Partners LLC and Friends for

those certain premises located at 217 North 10th Street, Brooklyn, NY (the "N 10th Street Premises"); and

WHEREAS, Friends desires to sublease the N 10th Street Premises to the School and the School desires to sublease the N 10th Street Premises from Friends pursuant to a sublease (the "N 10th Street Sublease") as more fully set forth in the N 10th Street Sublease (collectively, the N 10th Street Sublease and the Lewis Ave Sublease shall be referred to herein as the "Subleases"); and

WHEREAS, subject to Minor Modifications to be made to the N 10th Street Sublease through negotiations between the School's and Friends' legal counsel, the School wishes to enter into the N 10th Street Sublease;

NOW THEREFORE, BE IT RESOLVED, that the Board hereby approves the Assignment, the Subleases and the Guaranty, and authorizes the School's Proper Representatives to work with the School's and Friends' legal counsel to finalize the Assignment, the Guaranty and the Subleases with Minor Modifications;

BE IT FURTHER RESOLVED, that any Trustee or officer of the School or the Board's designee or the School's Executive Director (each, a "**Proper Representative**"), be and hereby is authorized and directed, jointly and severally, to execute and deliver the Assignment, the Subleases, the Guaranty and any other documents consistent with the transactions described above and such further agreements, assignments, pledges, instruments, consents and documents ancillary to the Assignment, the Subleases, the Guaranty or necessary in the determination of any Proper Representative, in the name of and on behalf of the School, and to pay all such expenses and taxes as in their judgment shall be necessary, proper and advisable in order to fully carry out the intent and accomplish the purposes of the foregoing resolutions; and

BE IT FURTHER RESOLVED, that all actions heretofore taken by any Proper Representative, for and on behalf of the School in connection with the Assignment, the Subleases, or the Guaranty including, but not limited to, the execution of the Assignment, the Subleases, and the Guaranty shall be and hereby are ratified and approved, and that the authority given hereunder shall be retroactive and any and all acts hereunder performed prior to the passage of these resolutions are hereby ratified and approved.
