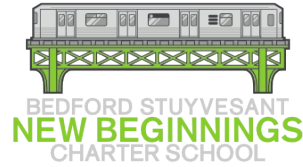

The trustees discussed the 8th grade students who are stepping up and the process to join our high school and the process for applying to other schools.
