Board Chair Mohamed presented the 2026-2027 budget projects enrollment of 1,860 students with an ADA rate of 94%, and LCFF COLA revenue is expected to increase by approximately 4.31% compared to 2025-2026. Staffing costs will increase by \$1.2 million due to salary schedule adjustments, longevity eligibility, and additional support staff, while employee benefits will rise by approximately \$161,530 (4%). These increases are partially offset by an \$836,000 reduction in supplies and operations costs, resulting in a projected surplus of approximately \$124,000.
