Grades 1&2 - Maria Gibson

This week in Math:

Daily Practice (all grade levels): Adding by tens and counting by tens.

1st Grade: We are learning about fact families.

2nd Grade: We are learning about place values and how to

group numbers into different formats. Unifix cubes and visual drawings are a great tool to use

and demonstrate!!

This week in Language Arts:

ELA Centers: Choral reading with Ms. B. Writing with Ms. Brinks and Phonological Awareness with me on the carpet. Students are working hard and improving these crucial skills for language development.

Wit & Wisdom Curriculum (All Grades): We are on Lesson 13 and read the Rough Face Girl and Big-Foot Cinderella this week which students really enjoyed. We analyzed the story elements, learned new vocabulary and discussed character traits effectively.

Social Studies: We are reading about Civics, Government and Citzenship. This week focused on caregivers, their job and their role.

Science: Animal & Plants Superpowers. We watched and discussed animal traits they inherit from their parents and animals' ability to camouflage.

We are a strong and energetic class this year that will discover many new and exciting skills!!

Grades 3&4- Natalie Shoptaw

We spent the first two weeks practicing norms, procedures, protocols, and reminding of expectations. We reviewed basic 2nd grade grammar, introduced the chrome books and Google Classroom and other fun things. Kids have been out of school for over a year and as such had grown rusty on standard protocols; completely understandable.

Our 3-4 class contains quite a number of students that come from elsewhere (outside of TRCS), several of whom have pre-existing 504s or IEPs. Our new special ed provider, Courtney, is great to work with!

We have jumped into both our Wit and Wisdom curriculum and Bridges Math with both feet.

We are looking forward to partnering with the junior high in the upcoming Buddies program. About 3 weeks each month, on Fridays, Buddies will read Studies Weekly together. This will be great scaffolding for my students who are not yet up to grade level reading. After the reading the buddies will work together on the social studies written work contained in Studies Weekly.

It is wonderful to be in the classroom again!

Grades 5&6- Dani Krebs

This has been an exciting few weeks for the 5th and 6th graders. We are delving more deeply into the REACH goal of empathy and learning what that means about ourselves and others. We watched a 9/11 video of how the attacks allowed people to feel empathetic and give back to their community, and we are making cards for a children's hospital in Illinois. I am going to be mailing the cards next week. My goal is to spend two weeks per REACH value to really try to understand what each REACH value means.

The 5th and 6th grade had our first Buddy Friday and it went amazing! We teamed up with the 1st and 2nd grade class and read Scholastic magazines. This week we are going to build buildings using spaghetti and marshmallows.

We are getting into the swing of things academically, and I am really enjoying Wit n Wisdom. The topics that they talk about go hand in hand with our REACH values, so the students are learning curriculum and behavior at the same time. We started Studies Weekly in history and the students seemed really excited about the crossword puzzle. I completely understand because I love puzzles too.

In specials we are going to start reading a play about dragons and wizards and princesses. The students want to perform in front of other classes so we will see how they do!

Grades 7&8 - Michael Lang

This first month of our class has been filled with many learning opportunities. Rule #3 in our class is "Mistakes are Mandatory" and we're learning to embrace our mistakes and improve our skills and knowledge as a result. We're so thankful to have Ms. Sofi, who has been an integral piece of getting and keeping everything rolling smooth. Each day of the week, we start with using different news sources to keep up to date on all the happenings, from the local water crisis to keeping up on the stock market for our Investment Project each Wednesday. We also

take some time in the morning to practice our art skills and have already made multiple pieces of art to contribute to the other classes, including REACH posters and number lines.

Our current studies in the Humanities (ELA and History) focus on the founding of our country. Our current novel study is the first book in a three-part series of historical fiction, set during the American Revolution and designed to provide the opportunity to explore multiple perspectives. This series provides many excerpts from documents written during that time period, which allow us to see the way of thinking almost 250 years ago. We'll begin learning about the founding documents of our country in the coming weeks.

We are taking a blended approach to mathematics this year. Our class is receiving tiered instruction that allows access to all grade level standards, from those pre-requisite skills that some of our students need support with, to the higher Algebra I standards for some of our higher achieving mathematicians. This joint learning experience allows us to continue to support each other in the learning process, while still giving everyone the individualized attention they need.

We've just begun learning about life science and are exploring the foundation of all living organisms, cells. We're very excited to begin taking trips later this semester to study our local marine ecosystem and apply our new knowledge to our community.

Lastly, a small portion of our class has set forth on an elective project to renew our playground. We're very excited to be in the planning phase of acquiring materials and constructing a new perimeter. We're very thankful for the amazing opportunity this provides to give back to the school community with our hard work.

Covid Pay Policy

TRCS-P-3.28

This policy is designed to provide TRCS staff members additional sick pay should they miss work due to Covid-19. During the Covid-19 health emergency, it is the board's intent to provide additional sick pay or sick days to employees missing work due to Covid-19.

This Policy shall be in effect from the start of the 2021-2022 school year, August 20th and is retroactive to that date.

This policy applies to any employee who is unable to work or telework for one of the following reasons:

- The employee is subject to a quarantine or isolation period related to COVID-19 as defined by an order or guidelines of the California Department of Public Health, the U.S. Centers for Disease Control and Prevention, or a local health officer who has jurisdiction over the workplace.
- A health care provider has advised the employee or provider to self quarantine because of COVID-19—related concerns.
- The employee is attending an appointment to receive a COVID-19 vaccine.
- The employee is experiencing symptoms related to a COVID-19 vaccine that prevent the employee from being able to work or telework.
- The employee or provider is experiencing COVID-19 symptoms and is seeking a medical diagnosis.

• The employee is caring for a family member who is subject to an order or guidelines described in qualifying reasons above. Family members include the employee's spouse, registered domestic partner, parent (including parents-in-law), child (regardless of age or dependency), grandparent, grandchild, and sibling.

• The employee is caring for a child whose school or place of care is closed or otherwise unavailable for reasons related to COVID-19 on the premises.

Salaried employees shall receive up to 10 additional sick days per year should they miss work for the qualifying reasons in this policy.

Hourly employees shall receive up to 10 days sick pay at their regularly hourly rate based on average hours worked in a regular week.

Scenario 2 in TRCS Covid-19 Protocols is for:

An unvaccinated asymptomatic student/staff member who has close contact with a COVID-19 positive case outside of school.

Current version:

- Student/staff report information to administrator.
- Student/staff are invited to take a BinaxNOW test 3-5 days after exposure.
- The unvaccinated student/staff member is sent home and may return after 10 day quarantine. Independent Study provided.
- School will remain open.

Proposed Change (that aligns with California Dept. of Public Health guidance):

- Student/staff report information to administrator.
- Student/staff are invited to take a BinaxNOW test 3-5 days after exposure.
- Unvaccinated student is sent home for a 5 day quarantine. A PCR test may be taken on day 6 and if negative, the unvaccinated student may return to school on day 7.
- Unvaccinated staff is sent home and may return after a 10 day quarantine.
- School will remain open.

BinaxNOW is an antigen test that identifies if a person is infected with COVID-19. This test can be administered on the TRCS campus by trained staff. This is a nose swab test.

Close Contact is a person who has had contact with a COVID-19 positive person for 15 minutes or more cumulatively over a 24 hour period, within less than 6 feet distance masked or unmasked.

Epi-linked means that individuals infected with COVID-19 are epidemiologically linked in their transmission. This means they had contact with one or more of the same people who are also COVID-19 positive.

Isolation only pertains to individuals who test positive for COVID-19 regardless of vaccination status:

- This is usually a 10 day period.
- The infected individual stays in a space away from others.
- The infected individual is not permitted on any school campuses until after the isolation period has expired AND the individual is symptom free **AND** the individual is released from Public Health.

Mask on Mask means that the contact and case were both wearing a mask during exposure.

Modified Quarantine only pertains to unvaccinated individuals who have had close contact at school:

- This is a 10 day period.
- Students continue to attend in-person instruction.
- Students are tested twice a week at school with BinaxNOW for two school weeks (10 days).
 - o If a student tests positive, they are moved into isolation and transferred to independent study for 10 days from the day they tested positive.
- Students are not able to participate in any extracurricular activities (Tides After School, Homework Club, Band, etc.) for the duration of the modified quarantine period regardless of BinaxNOW results.

TRCS COVID-19 Action Plan Moving to Independent Study or Remote Learning

- Should TRCS or a classroom require closure due to COVID-19 as recommended by the Mendocino County Public Health Officer, TRCS will move students to independent study or remote learning to continue educational delivery.
 - o Within the first 30 days of school, all TRCS students will be assigned a Chromebook for the 2021-22 school year.
 - All teachers will work with their students and their families to prepare for a potential closure.
- Google Classroom will be the primary delivery platform.
- Students will be trained on how to access their online educational accounts.
 - Families will be notified via email of the number of positive COVID-19 cases at the school.
 - o TRCS will issue a warning should the number of cases rise to a level that threatens a potential school or classroom closure.
 - Students and families will have a minimum of one school day to collect materials before moving to remote learning.
 - TRCS will notify families of any school closure through email and phone. This notification will also be placed on the TRCS social media pages as well.

DEFINICIONES

BinaxNOW es una prueba de antígeno que identifica si una persona está infectada con COVID-19. Esta prueba puede ser administrada en cualquier campus de FBUSD o en la Oficina del Distrito por personal capacitado. Esta es una prueba de frotis nasal.

Close Contact es una persona que ha tenido contacto con una persona positiva a COVID-19 durante 15 minutos o más, enmascarada o desenmascarada.

Vinculado a Epi significa que los individuos infectados con COVID-19 están vinculados epidemiológicamente en su transmisión. Esto significa que tuvieron contacto con una o más de las mismas personas que también son positivas para COVID-19.

El aislamiento solo se aplica a las personas que dan positivo en la prueba de COVID-19 independientemente del estado de vacunación:

- este es un período de 10 días.
- El individuo infectado permanece en un espacio alejado de los demás.
- La persona infectada no puede ingresar a ningún campus escolar hasta después de que el período de aislamiento de 10 días haya expirado Y la persona no tenga síntomas.

La cuarentena modificada solo se aplica a personas no vacunadas:

- este es un período de 10 días.
- Los estudiantes continúan asistiendo a la instrucción en persona.
- Los estudiantes son evaluados dos veces por semana en la escuela con **BinaxNOW** durante dos semanas escolares (10 días).
 - Si un estudiante da positivo, se lo traslada a un lugar de aislamiento y se lo transfiere a un estudio independiente durante 10 días a partir del día en que dio positivo.
- Los estudiantes no pueden participar en ninguna actividad extracurricular (atletismo, porristas, clubes, etc.) durante el período de cuarentena modificado independientemente de los resultados de BinaxNOW.

Plan de acción COVID-19 del TRCS Pasando al aprendizaje remoto

- Si la escuela o salón de clases del TRCS requiere el cierre debido al COVID-19 como es la recomendado por la Oficina de Salud del Condado Mendocino y el personal pasarán al aprendizaje remoto.
 - o Dentro de los primeros 30 días de clases, a todos los estudiantes de TRCS se les asignará un Chromebook para el año escolar 2021-22.
 - Todos los maestros trabajarán con sus estudiantes y sus familias para prepararse para un posible cierre.
- Google Classroom será la plataforma de entrega principal.
- Los estudiantes recibirán capacitación sobre cómo acceder a sus cuentas educativas en línea.
 - Las familias serán notificadas a través de Parent Square del número de casos positivos de COVID-19 en la escuela de su estudiante.
 - o TRCS emitirá una advertencia si el número de casos aumenta a un nivel que amenaza con un posible cierre de la escuela o el aula.
 - o Los estudiantes y las familias tendrán un mínimo de un día escolar para recolectar materiales antes de pasar al aprendizaje remoto.
 - TRCS notificará a las familias de cualquier cierre de escuela a través de correo electronico y telefono. Esta notificación también se colocará en las páginas de redes sociales de TRCS.
