## Move Out Expense Proposal for the Board April 2024

In order for floors to be replaced this summer, all the contents of the school must be removed and stored during construction. Below are proposed expenses to support the move out including movers and storage containers.

### 1. Alder Moving Services \$5000

Thursday, June 13th - 4 workers @\$275 per hour (\$2500) August date TBD to move back in (\$2500)

### 2. Coast Containers \$3600

(6) 20' x 8' containers

\$200 delivery/pickup fee per container (\$1200)

\$100 rental fee per month x 4 months (\$2400)

We will begin strategically loading containers in May. As June approaches, more containers can be added if needed.
