III. Data Dive: EOY Academic Results

A. Academic Results

A. Mehta presented on the end of year academic results. Discussion points included details regarding goals versus actual results for reading and math, as well as growth targets. There was a group discussion regarding criteria for determining the goals. Median percentage progress was shown across academic year, subject, and school, as well as a summary of school-specific grade level progress in reading and math. In reading, KTVM had all grades exceeding the previous school year metrics, and in math both KTV schools had all grades exceeding the last school year metrics.

S. Valle presented on the KTPH graduation data. A group discussion followed regarding regents data.

IV. Key Updates

A. Student Enrollment

G. Boyd presented on student enrollment matters. The goals for the 24-25 school year student recruitment is to have 100% of KIPP campuses fully enrolled by the first day of the school year. As of last week, we have hit 740 applications for the Fall. KIPP Albany Community and KIPP Troy Prep are both predicted to be at full enrollment. Each campus is actively canvassing for potential additional applicants.

B. School Staffing

S. Valle presented on school staffing matters. The schools are tracking ahead of where they are last year but there are still several positions still vacant for the 24-25 school year. KIPP is using an outside recruiter to find more candidates.

C. Bond Closing and HS Construction

S. Valle provided an overview on the bond closing that occurred today. There will be a "Beam Raising" in August.
