III. Facility Update

A. Update

Ms. Kathy Ortiz shared that LaBella Associates is scheduled to commence the building conditions assessment for 950 Longfellow on June 24th. Ms. Ortiz also shared that the School received a proposal from Ciardullo Architecture & Engineering, reflecting a cost of \$35,600 to conduct a feasibility study that will help determine whether or not we can add another floor at 950 Longfellow Ave.

Susan Geisenheimer made a motion to empower Kathy Ortiz, Executive Director of Bronx Charter School for the Arts, the authority to accept the fee proposal from Ciardullo Architecture & Engineering to complete building feasibility study for 950 Longfellow Ave, upon the review, consultation, and approval from the assigned board members supporting real estate and building needs of the School.

A. Update

Ms. Jasmin Abbatiello discussed fundraising goals, objectives, and outcomes, which included a close look at campaigns over time. She noted that as of June 7th, a total of \$576,898 in cash contributions (\$425,000 goal) and \$638,377 in cash and in-kind contributions (\$450,000 goal) has been raised.

Jasmin Abbatiello also discussed other accomplishments throughout the year, including:

- · Digital recruitment campaign
- Significant growth across social media platforms
