II. Academic Excellence Committee

A. Summary and Key Takeaways from visit to Francis Parker Essential Charter School Overview of Parker

- grade 7-12, 400 students, reformed military base
- one of the first Charter schools, Essential school
- on location Teacher Prep program partnered with Fitchburg State
- "the Parker Way" Common Principles of Essential Schools
- combination of classroom visits, Parker 101, meeting with students to discuss portfolios, met with Dean of Academics
- 3 Divisions, start and end day in Advisory, 4 blocks Arts and Humanities; Math, Science and Technology; Spanish; and Wellness
- Wednesday early dismissal, end the day with extended Advisory, then teacher meetings: faculty meetings, Division meetings, Critical Friends Group
- Gateway (promotion) to the next division. If students show mastery in a domain, they can advance early, if they need more time, they can stay up to an extra year
