Dear MCCPS Board of Trustees and Governance Committee,

Attached you will find my resume outlining my work as an educator and business leader. You will also see the ethos of MCCPS woven into everything I have accomplished. I have had a lifelong relationship with the school– beginning long before, and continuing long after my time as a student ('09). It is time for me to give back to the school and its community, and with my unique blend of relevant experience, I am interested in becoming a member of the Board of Trustees.

Professionally, I have led or participated in several education-related projects and partnerships. As a Camp Program Director at the North Shore YMCA, my team grew and developed the Lynch/van Otterloo (LVO) YMCA's Adventure Camp program, leading to my promotion to Assistant Camp Director of Specialty Camps, where I gained experience training and leading a large and diverse team. I was also a member of the team that launched the LVO Swampscott Education Center, a preschool and after school center focussed on STEAM learning to supplement academics. As the inaugural Site Coordinator for the Center, I developed connections with stakeholders which led to the center's growth in a new community. As Youth and Family Supervisor at JCC of the North Shore, my team improved Camp and After School operations through implementation of simple and effective processes for employees and families, and helped the organization to respond to changes necessitated by COVID-19.

Most recently, as Co-Founder and COO of Island Roots Camp Group, I have gained the knowledge required to scale and lead a business, including organizational design and business finance. Offering Summer Camp and Extended Day Programs year-round with a mission to *empower generations of kind*, *capable*, *and conscientious individuals*, Island Roots has grown from 4 participants in November of 2020 to over 400 families across 7 schools in Northeast Massachusetts. This growth has been made possible by creating a culture of trust, collaboration, and dedication to the mission within our team of full and part time employees.

As you can see, my experience revolves around programs which promote integrated, project based, and experiential learning models. I hope that I can use this experience to support the MCCPS community that has been such a core pillar of my success.

Please consider me for any Marblehead Community Charter School Board/Committee opportunities. I have included my resume for your assessment.

It would be an honor and pleasure to serve the Marblehead Charter School. My daughter Tilly will be entering MCCS this fall as an incoming 4th grader, a fact I am very excited about.

I have practiced as an attorney and as a Guardian ad Litem in many of the counties, courts and school systems in Massachusetts since 2003. During that time I have striven to maintain collegial relations with all of my colleagues, the Justices, and the various collateral agencies including the Department of Children and Families, the school systems I work with, and my clients, and I think I have succeeded.

My work for the last 20 years has primarily involved representing children, parents and guardians in child protection matters involving serious abuse and neglect, domestic violence, substance misuse, physical abuse of children, and mental health. I frequently serve as a guardian ad litem for education, medical treatment, and as an advisor for court-involved juveniles regarding everything from deathbenefits to injury litigation. I have had educational signature authority over the special education plans of hundreds and hundreds of children. I've also recently worked as an attorney for a local child care institution that was facing reports of neglect by staff and made recommendations to the board of directors regarding how they could respond and revamp their practices.

After I was honorably discharged as an officer in the U.S. Army, I taught high school in a historically black school in Columbus, Georgia where I was appointed social studies department cochair, and taught special education in Central Massachusetts. I have served on a variety of committees during my teaching career. Teaching was a rewarding career for me, although I probably spent a little too much time doing mock trials with my classes. I earned a Masters degree and certification in school administration, which has been helpful in my practice.

Although my practice involves a significant amount of trial work, I am more a conciliator by nature, preferring to work closely with families and institutions to craft fair and workable solutions to complicated matters, as opposed to litigation.

I see education as a life-long journey, as opposed to a destination. I believe in process and I believe in hearing people's views. I believe in giving people a helping hand. I accept that my various roles require me to make decisions that impact people's lives, and I try to do so in an ethical and responsible manner. and after listening to the various stakeholders.
