<p>Ms Pieper has registered for the webinar this afternoon and will get us registered with the program.</p> <p>In total, \$150 million of American Rescue Plan Act funding was allocated by the North Carolina governor and approved in the legislative budget. As this is a legislatively mandated effort, facilities are required to meet rule requirements (<a href="#">NC 10A NCAC 41C.1001-1007</a>, <a href="#">NC 154A NCAC 18A.2816</a>).
