SARCs for all California public schools are available on the CDE website.

Discussion on comparing and contrasting our results to peer schools across the state. Points also made on test scores, our results, and plans to improve both the number of scholars who test and our overall results. Mention of tie-in to the Local Control Accountability Plans (LCAPs) and budgeting process. Points also made on UC/CSU course competition rates. Mention of leadership staff currently attending training on the SBAC testing process.

Academic Affairs Committee will hold a special workshop in March to review SARCs in more detail, along with peer results, and talking points to speak to AAS data. J. Manwarren made a motion to approve the 2015-16 School Accountability Report Cards.

### Staff Report October 16, 2017

This report is meant to provide updates to the Board of Directors Academic Affairs Committee:

### AVID

45 scholars are enrolled in our AVID Elective class. Members of our AVID Site Team have attended numerous trainings to better support our scholars, including training on critical reading and collaborative study groups. Teachers in our Online High School have been incorporating AVID into their classrooms, such as philosophical chairs and the use of Cornell notes.

### <u>Class of 2018</u>

CCS celebrated its first graduate of the 2017-2018 school year last month. The scholar is happy to have earned her HS diploma and looks forward to starting CC in the near future.

### **Counseling Services Workshops**

The Counseling Services Department is hosting a number of workshops throughout the month of October. Topics are geared toward either middle school or high school scholars. *See attached flyer for more information.* 

### Engagement Events

The Engagement Department has scheduled a number of field trips and enrichment activities for scholars throughout the state. *See attached flyer for more information.* 

### i-Ready Diagnostic Testing

Our new and returning scholars have completed their i-Ready Diagnostic Test. New scholars will continue to be tested as they enroll with us. Scores will be uploaded into our Scholar Information System (SIS) and Parent Scholar Portal (PSP). The i-Ready results will help teachers assess the needs of each and every scholar in their class while monitoring progress and growth throughout the school year.

### Individualized Education Program

The Special Education Team has led six (6) initial IEP meetings with scholars, families, and general education teachers, as well as 25 30-day IEP meetings.

### Parent Teacher Conferences

Our Online Program will be hosting Parent Teacher Conferences from November 6<sup>th</sup> through November 17<sup>th</sup>. This is one of the many enhancements that have been made to our online program this year to better support our scholars.

### Science Wet Labs

We are hosting synchronous and asynchronous biology, chemistry, and physics labs every month this school year (days, time, and locations to be determined). They will be held in Fresno, Los Angles and Santa Ana. We currently have 42 scholars enrolled in biology, 15 enrolled in chemistry and 5 enrolled in physics.

### **Truancy Update**

Per our Independent Study Policy, which was approved by the Board of Directors in January, and our signed Master Agreements between scholars, learning coaches and supervising teachers, if a scholar fails to submit at least five (5) assignments within a 10-day span, they are considered truant and meet with the President & CEO to see if independent study is an appropriate and supportive learning environment. Here are our truancy numbers, as of October 9<sup>th</sup>:

- Online Elementary School: 3 scholars
- Online Middle School: 2
- Online High School: 23
- Options Program: 1

### Vendor Relations

Our Vendor Department has been working hard to increase our vendor offerings for curriculum, classes, and materials for our Options scholars. We currently have close to 400 vendors available. The complete list can be found on our website, under Academics > Options Program.



October's Theme--Haywire Scholars Week Four: What can I do if a scholar logs in but doesn't complete work?

DEVELOP A RELATIONSHIP WITH ALL SCHOLARS IN YOUR HOMEROOM!

1) Catch them when you see they are online and start a chat!

- 2) Have them message you back in SM by telling you what they like to do for fun, what their favorite subject is, something unique about them, etc. This will be an ice-breaker that will soon become the bond between you and your scholar(s).
- 3) Then, state that you've seen that they logged in but haven't submitted work-find out the reason and remember to project SUPPORT. Remind them you are there to help and want to see them succeed.
- 4) Provide suggestions when they give you an answer, "I'm distracted"
  - a) Solution: Set up a work station and turn off all electronics
  - b) Take breaks every 2 hours or so and get in physical activity and food (food is fuel) in the meantime
- \*The scholar may then feel more apt to submit work because they know someone is "watching" them...



Attrition rates for classes taught through distance education are 10-20% higher than classes taught in a face-to-face setting. Educators should engage scholars early and often, using different learning

strategies customized to the class content and the scholars' pre-existing knowledge. The goal for the IRR teacher s to develop relationships with the scholars so they feel comfortable in the environment. The teacher should facilitate learner-learner integration and collaboration so that they will learn from <u>one another</u> and expand their knowledge have <u>logether</u>.

#### **REMINDER FOR HOMEROOM TEACHERS--**

- i-Ready- please ensure your scholars have completed the initial iReady diagnostic tests. We have extended the deadline to 10/14/17, but our goal is to have all scholars complete both assessments by Friday.
- 2) Learning Laba- den't forget to remind your scholars to arterd Learning Labd If a scholar-absolutely connot attend them live (Secure their schedule doesn't allow for it) remind them to watch the recording! However, have the conversation with families and state how important it is to attend them live to develop social skills and relationships with clossmates and reachers.
- Reinforce coursework deadlines- all scholars should be focusing on completing and submitting work <u>on time</u>.

October's Theme--Haywire Scholars WEEK SIX 5 Tips and Tricks to Actually Get Your Scholars to Complete Work

 Over Communicate: post clear directions in courses, email, call, textbe in constant communication with LC's and scholars so your expectations for completing work is easily accessible. Never give your scholars the opportunity to use the excuse, "I didn't know it was due."



- 3. Offer Help Sessions: offer additional help sessions for your classes at different times throughout the day. This makes help available for struggling scholars while also making it their responsibility to take advantage of this resource. If you're having trouble getting these struggling scholars to even show up to your Learning Labs, remind them via email, text, and give them a call. When they do eventually come, praise them for coming and hang back with them for a one on one session. The positive reinforcement will motivate them to make attending Learning Labs a regular occurrence.
- 4. Empathize with Scholars: sometimes scholars feel as though their teachers are out to get them to make their lives miserable by making them do work. Why not take the time to show them this is not the case? Express that you know you are asking them to do something difficult, and ask if they can try anyway. Reassure scholars that you are there to help during any rough patches, and ask how often they'd like you to check in on them (and don't forget to check in- this will make them feel supported in your class).
- 5. Find Out Their "Why:" more times than not, there is a specific reason why a scholar is not completing work. Maybe they're having trouble getting started on an assignment and shut down when they get overwhelmed? Maybe they are distracted working at home and can't focus? Maybe they are having technical issues and need assistance with a loaner computer or a walk through of the system? Take the time to find out why a scholar is struggling and offer help getting past these roadblocks. Also, find out what they want to be when they grow up, and relate your course content to their aspirations so they understand why they need to be keeping up on school work to be successful in the real world.

#### September's Theme--Scholar Absenteeism Week Three: Why is attendance imbortant for scholar success?

Chronic absence predicts lower third-grade reading proficiency, course failure and eventual dropout, it weakens our communities and our local economy

Chronic absence - missing 10 percent or more of school for any reason including excused and unexcused absences, or just two of three days a month - is a proven predictor of academic trouble and dropput rotes

The import of chronic absence hits low-income scholars and children of color particularly hard if they don't have the resources to make up for lost time in the classroom and are more likely to face systemic barriers to getting to school - such as unreliable transportation, lack of access to health care, unstable or unaffordable housing



"Scholars can still fall behind if they miss just a day or two days every few weeks. "Being late to school (starting later than "normal") may lead to everall poor attendance. "Absences can affect the whole classroom (Learning Labs) if the teacher has to slow down learning to help scholars catch up/fill them in on the topic for the day. "Attending "school" regularly helps children feel better obout school-and themselves.

#### WHAT CAN YOU DO?

- HR Teachers can reach out more frequently to absent scholars to determine what barriers they face and what would help them complete work more regularly.
- a) Provide suggestions for those barriers (see RTI interventions for more specifics)
  2) Have LCs start building this habit in the early grades so they learn right away that going
- 2) Have LCs start building this habit in the early grades so they learn right away that going to school on time, every day is important. Good attendance will help children do well in high school, college, and at work.
- 3) Tell LCs: don't let their child not complete work for the day unless he/she is <u>truly</u> sick. Remind them that the beauty of this program is that they are working from homel Even if a scholar is not feeling 100%, they can take breaks during the day and still complete assignments...on the cauch if they have to...not ideal, but it workil
  - a) Keep in mind complaints of a stomach ache or headache can be a sign of anxiety and not a reason to complete work for the day...


## **Quick Overview of Responsibilities:**

- Extension Award Letter (issued by JJ)
- Withdrawal Notification Letter (issued by JJ) which is part of cumulative file



# COMPASS CHARTER SCHOOLS

## Academic Affairs Committee Board of Directors

### Purpose

The Academic Affairs Committee is responsible for reviewing academic issues, programs, and policies at Compass Charter Schools to ensure that they are consistent with its Mission, Vision, Values, and Strategic Plan.

### **Structure and Operations**

Members: The Committee shall be comprised of three (3) members; two (2) members of the Board and one (1) member of the Senior Management Team. The members of the Committee shall be appointed annually by the Board upon the recommendation of the Governance Committee.

Chair: The Chairperson of the Committee shall be appointed by the Board upon the recommendation of the Governance Committee.

Appointment and Removal: The members of the Committee may be removed or replaced, and any vacancies on the Committee shall be filled by the Board upon the recommendation of the Governance Committee.

### Meetings

The Academic Affairs Committee shall meet at least four (4) times annually, or more frequently as circumstance dictate. Any director of the Board who is not a member of the Academic Affairs Committee may attend meetings; provided, however, that any director who is not a member may not vote on any matter coming before the Academic Affairs Committee for a vote. The Academic Affairs Committee also may invite to its meetings any director of the Board and such other persons as it deems appropriate in order to carry out its responsibilities. The Academic Affairs Committee may meet in executive session as necessary or appropriate.

### Responsibilities

- i. Assist in setting academic strategies
- ii. Ensure that all board members understand the key charter promises made to the community and authorizers.
- iii. Ensure that resources are allocated appropriately to support and sustain academic programs.
- iv. Ensure that the school's academic programs are appropriate for its scholars, and that scholars are well served by the school.
- v. Report to the Board of Directors and keep Board Members apprised of academic issues and the academic effectiveness of the school.


