The Chair is in charge of the meeting and will maintain order, set the time limits for the speakers and the subject matter, and will have the prerogative to remove any person who is disruptive of the Council meeting. The Scholar Leadership Council may place limitations on the total time to be devoted to each topic if it finds that the numbers of speakers would impede the Council's ability to conduct its business in a timely manner. The Scholar Leadership Council may also allow for additional public comment and questions after reports and presentations if it deems necessary.

Adventure to Fitness is a new free subscription to fitness resources for online elementary and options program scholars, and were shared in the MMU. Ms. Christopher suggested that perhaps asking scholars and parents for suggestions in their local areas would help with field trip planning, and believes that we should make each field trip educational and fun, not just one or the other. For example, going to Knott's Berry Farm would be fun but would also give scholars an education on California history.

Ms. Zorba found the survey to be helpful, and glad to now know the opinions and responses of scholars. She also strongly believes that we should listen to all the great feedback.
