The Chair is in charge of the meeting and will maintain order, set the time limits for the speakers and the subject matter, and will have the prerogative to remove any person who is disruptive of the Council meeting. 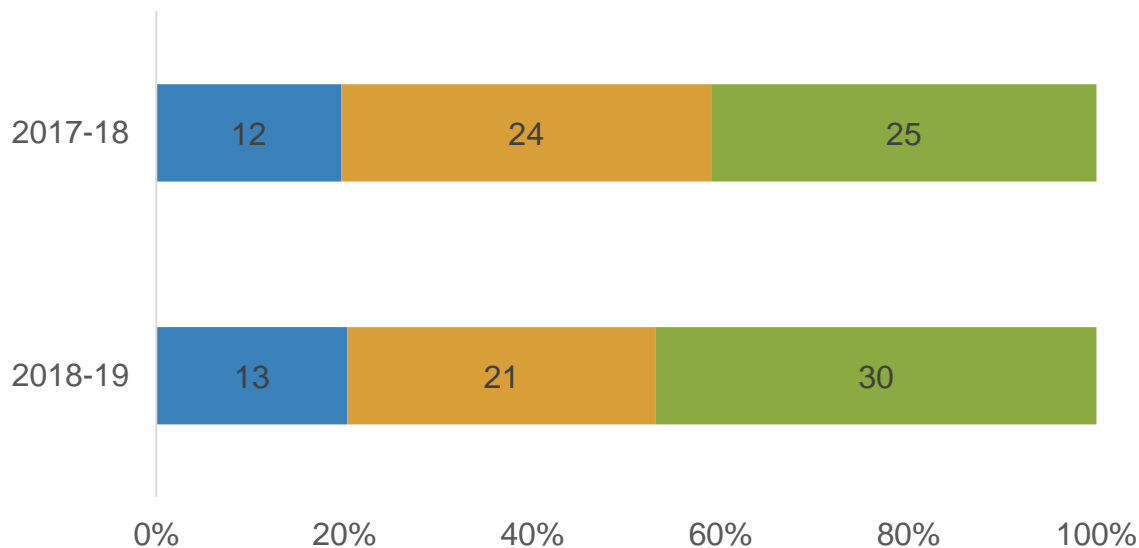

Grade Level



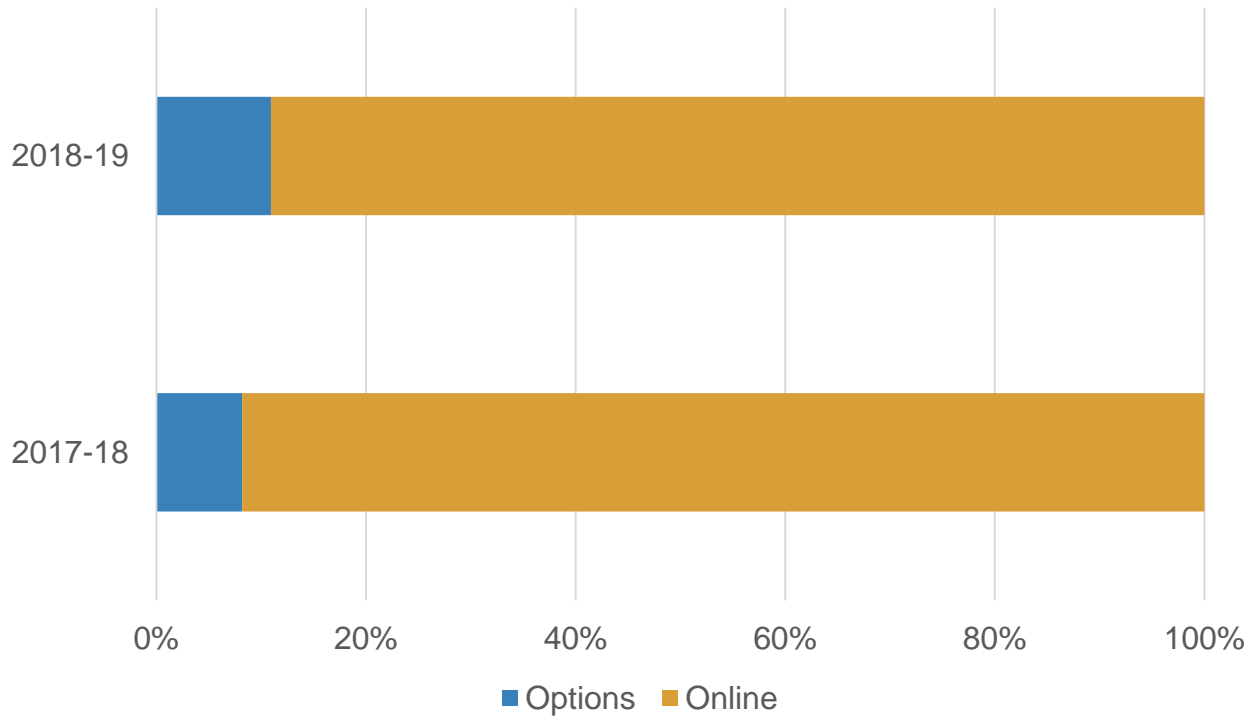

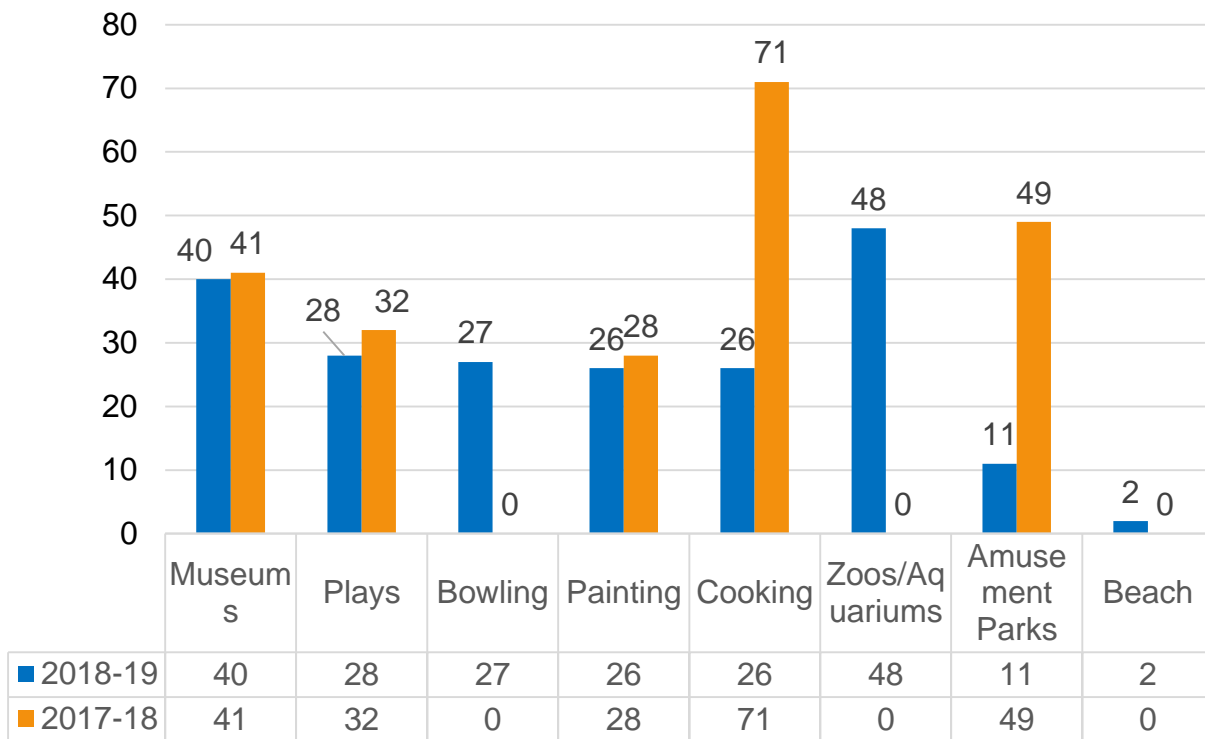
Program Enrolled In

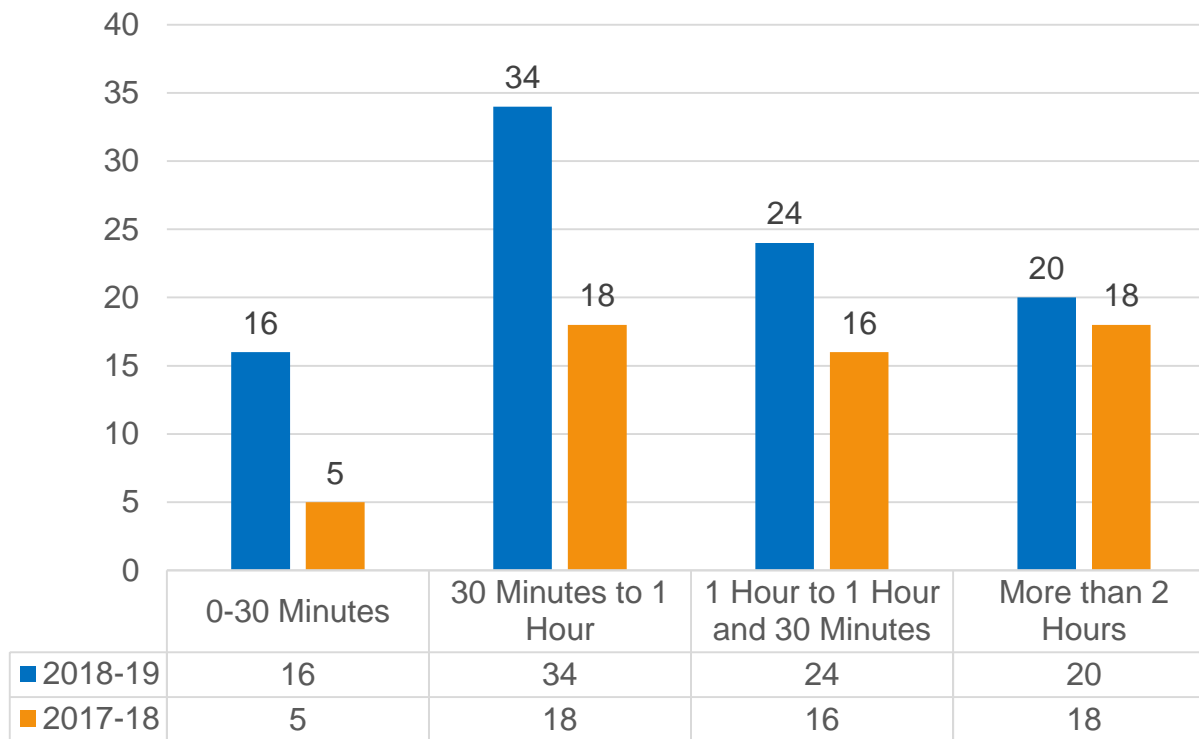
Field Trips Interested In Attending

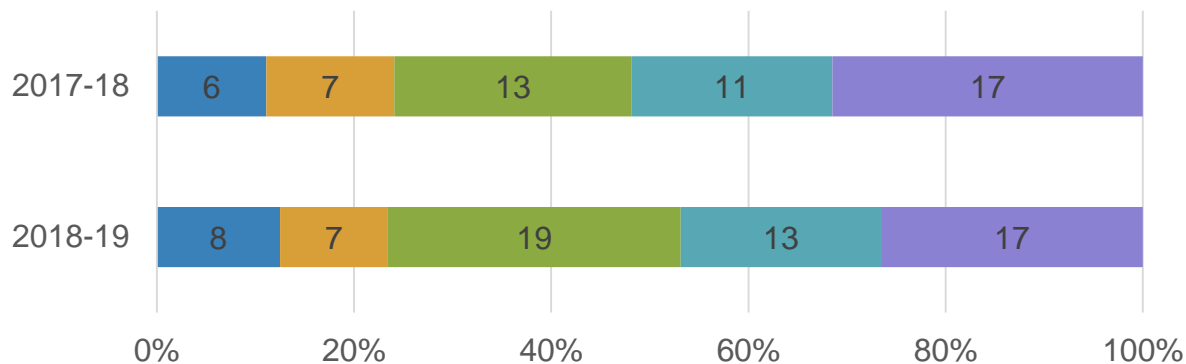
Time Willing To Spend Traveling

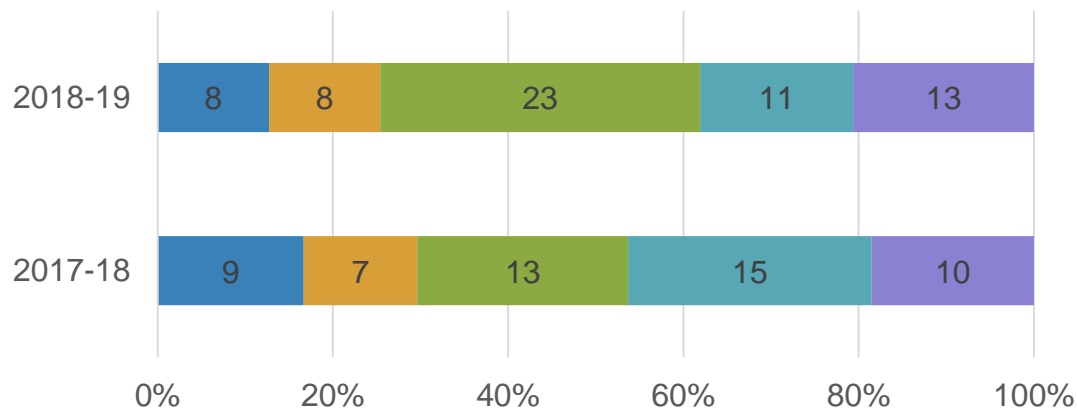

Attend Field Trips On Weekdays

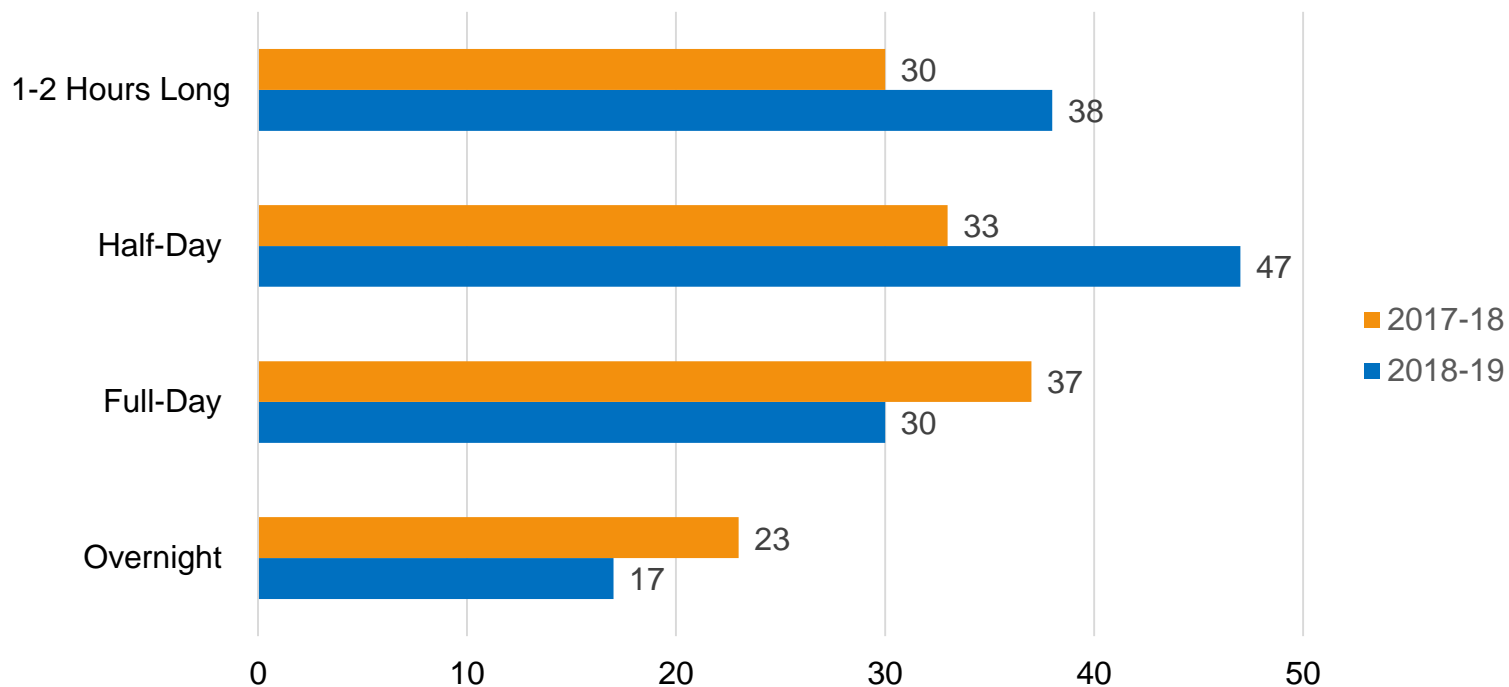

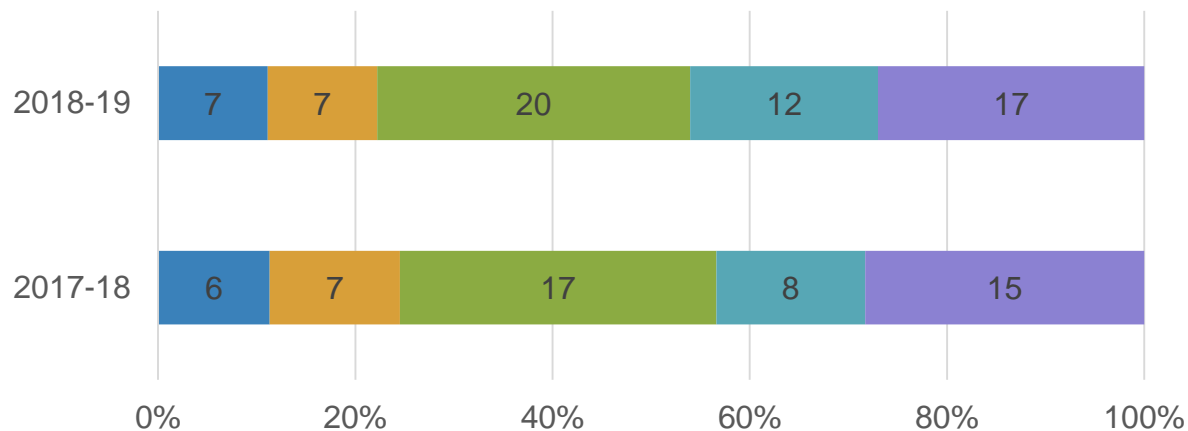

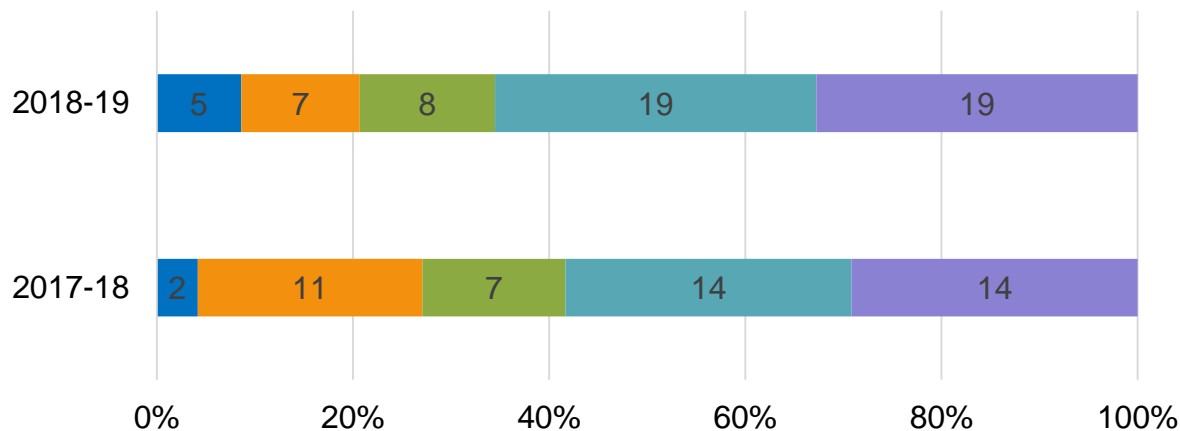

How often do attend Learning Labs?

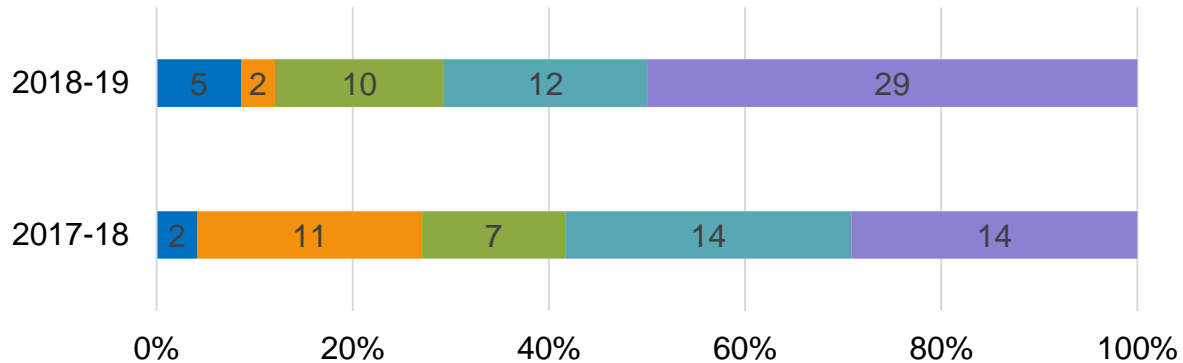

I believe Learning Labs help me better understand content in my courses

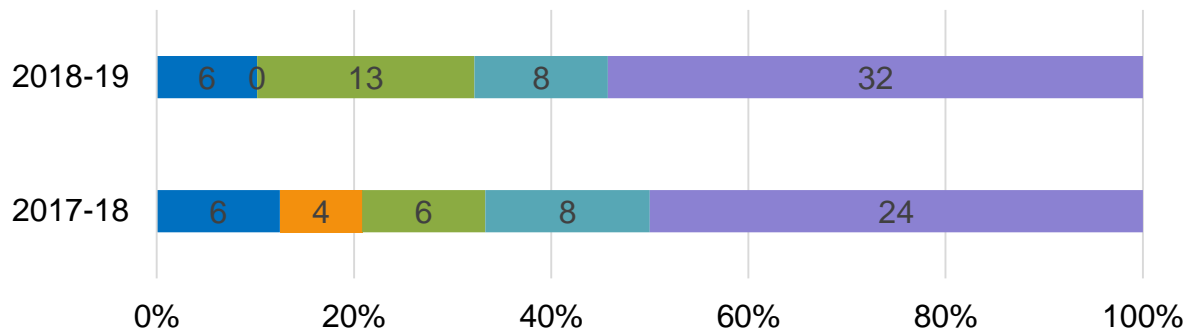
