#### A. Staff Report

Mr. Lewis led the council in an overview of the Staff Report. He shared an overview of SB-98 and its impacts on the operating budget. Enrollment is capped by charter and programs based on staffing and SB-98 impacts. Many schools have implemented an enrollment cap for the first time due to the funding structure set by the state. There are over 2,000 scholars on the waitlist.

He also shared an update on experiences and measures to prevent Zoom bombing. After further review and reflection, Compass suspended all Zoom Learning Labs until further notice. This will allow time to review options to provide and conduct a safe virtual learning experience with and for our scholars.

Mr. Avery Stansbury suggested creating a social justice club due to the times that we are in. The club could increase cultural and social justice awareness.

- The A-G / College Entrance Requirements are a sequence of high school courses that scholars must complete (with a grade of C or better) to be minimally eligible for admission to the University of California (UC) and California State University (CSU).
  - A= History/Social Studies (2 years required)
  - B= English (4 years required)
  - C= Math (3 years required, 4 recommended)
  - D= Science (2 years required, 3 recommended)
  - E= Language Other Than English (2 years required, 3 recommended)
  - F= Visual & Performing Arts (1 year required)
  - G= College-Prep Elective (1 year required)

# New changes and updates to A-G courses at CCS!

- 1. **Options Program:** Scholar may sign up for our exciting, new Options A-G courses, specifically designed for our Options scholars in Google Classroom.
- 2. **Online Program:** Proctoring of major assessments (i.e., unit tests, final exams) is now required for non-classroom based/independent study schools to maintain an A-G approved course list and coursework.





# NEW for 20/21 Options A-G courses

Options families have two ways to take A-G courses at CCS this year:

**Option #1:** Options A-G Courses in Google Classroom

 Scholars will have regular access to a subject matter expert teacher and spend at least one hour per week per course engaged in interactive instruction

**Option #2:** Enroll in up to 2 of our Online A-G courses in Accelerate Ed.

• Taught by our own Online teachers, who are credentialed in those specific subject areas.





### Our CCS Options A-G course via Google Classroom:

- Instructional resources and assignments are accessed via Google Classroom
- A schedule with weekly live support/Q&A sessions with a credentialed specialist
  - Schedule here
- Required course material (curriculum, textbooks or digital supports) will be communicated in each course syllabus and in the Google Classroom.
- Scholar work will be evaluated by an impartial professional who has been actively involved in the scholar's learning process (i.e. Supervising Teacher, subject matter expert teacher, etc.).

## **Accelerate Education A-G courses**

- Online Program Course List
  - $\circ$  85+ courses
- A credentialed content expert teacher who oversees the course.
- Supervising Teacher will support scholar in communication with content area teacher.
- Access is available via the Accelerate Education platform.
- All course resources are made available via the online classroom
- All assignments are submitted through Accelerate Ed.
- All major assessments will be proctored.
- The course teacher will provide a schedule of weekly live support/Q&A sessions; weekly participation is expected.
- Accelerate Education is \$300 per course per semester and will be reduced from educational funds.
