Messages must contain speaker name, contact number or email, and subject matter and sent prior to the beginning of the Public Comment section of the meeting. Members of the public may address the Council on any matter relating to the school and have **three (3) minutes each** to do so. The total time of each subject will be fifteen (15) minutes, unless additional time is requested by a Council Member and approved by the Council.

The Council may not deliberate or take action on items that are not on the agenda. However, the Council may suggest direction to staff following a presentation. The Chair is in charge of the meeting and will maintain order, set the time limits for the speakers and the subject matter, and will have the prerogative to remove any person who is disruptive of the Council meeting. The Parent Advisory Council may place limitations on the total time to be devoted to each topic if it finds that the numbers of speakers would impede the Council's ability to conduct its business in a timely manner. The Parent Advisory Council may also allow for additional public comment and questions after reports and presentations if it deems necessary.

IV. Reports

A. Staff Report

Mr. Lewis led the council in an overview of the Staff Report. He shared that we are in week three (3) of the 2021-2022 school year, and held in-person Back to School picnics earlier in the day. It was mentioned that there are open seats for prospective scholars in each of our charters and we are actively recruiting to fill those seats. Mr. Lewis mentioned a review of Weeks of Welcome (WOW) Program. There was also mention of the Learning Coach Academy, which is currently open for learning coaches to register:

He then welcomed members to share potential LCA topics with staff. ParentSquare and the new Monday Morning Update (MMU) layout were mentioned as part of the Staff Update. He also mentioned a Scholar Club NewsCast is forming to bring awareness to the MMU, the deadline to apply to Scholar Clubs was Friday, September 17, 2021. Mr.

Lewis also mentioned staff is also monitoring legislative updates, AB130, AB 167 which is the Education Budget Trailer Clean-Up Bill.

B. El Dorado Charter SELPA Community Advisory Committee Report

Mrs. Pugh gave an update on SELPA's next meeting on October 5, 2021.

Special Education is also providing additional support on MMU, ParentSquare, and providing SELPA resources.

V. New Business

A. Review and Discussion of Council Charge

Mr. Lewis and the council reviewed and discussed the council charge. Mr. Lewis reviewed the council charge and opened the floor for discussion. The Parent Advisory Council serves to ideate and share ideas/feedback on school policies and procedures at Compass Charter Schools to ensure that they are consistent with its Mission, Vision, and Values. This is the fifth year of operation for the Parent Advisory Council, to be the eyes and ears of scholars at Compass and share the good, bad, and ugly to talk about suggestions and ways to make improvements to the Compass Experience for scholars. As part of this discussion was a review of the 2020-21 PAC Annual Report, which can be found on the Parent Advisory Council webpage.

B. Discussion on Weeks of Welcome (WOW) Program

Mr. Lewis reviewed the 2021-22 Weeks of Welcome (WOW) program which includes Back to School Nights, program orientations, and department open houses. The WOW recordings can be found on the Compass YouTube channel:

It was mentioned that the total number of family registrations for WOW - 371

Mr. Lewis opened the floor for discussion and feedback.

C. Review and Discussion on the ESSER III Expenditure Plan

The Board of Directors, Parent Advisory Council (PAC), Scholar Leadership Council (SLC), Leadership Team, and the public all have opportunities to review and discuss at their respective meetings.

Mr. Lewis gave an overview update on the ESSERIII Expenditure Plan. He mentioned Compass's Mission, Vision, and Values, and ARTIC values.

The update includes an L.E.A. overview, a revenue overview, and an overview of the English Learners and homeless population.

Its mentioned that at least 20% of the ESSER III allocation much be used to address the academic impact of lost instructional time.

Mr.Lewis then proposed using the funds to address the academic impact of lost instructional time, additional subscriptions, summer school for all scholars, and credit recovery. Also, adding additional support for MTSS, hire a credentialed E.L.A., Math, and

Reading specialists for 3 years, and workshops for parents and scholars, and adding additional funds to S.E.L. workshops for 3 years.

D. Council Member Feedback

Mrs. Pugh asked: "How does the daily and none daily participation relate to tier engagement? and will it be a reminder notification or will it affect the actual reengagement structure and attendance to affect truancy?"

Mrs. Pugh suggested a FAQ or PDF punch list/format to protect privacy.

Mrs. Pugh asked, "May Compass provide the numbers on WOW's family participation?"

Mrs. Agravante asked: "How do I change my screen name, please?"

Mrs. Agravante asked, "Can Compass conduct yearly council member orientation?"

Mrs. Agravante asked, "Will the school year always start on September 1st moving forward, and if so, may Compass conduct WOW prior to Labor Day?"

Mrs. Agravante mentioned she would like to continue to see virtual coffee once a month by county.

Mrs. Agravante mentioned she would like to see Compass Social Hour sessions.

Mrs. Smith asked: "How is this proportionate to the overall budget and what is the official definition of an English Learner?"

Mrs. Scott mentioned the need to have subscriptions and learning resources even through summer and thus for the entire year until the next school year begins and the idea of access to Audiobooks and Ebooks.

Mrs. Agravante commented, "Agree with Lacey about the need to have subscriptions and learning resources even through summer and thus for the entire year until the next school year begins."

Mrs. Agravante asked, "Are we able to see both the regular budget together with the ESSER II funds placed together/juxtaposed with one another to get an overall view, if possible?"

Mrs. Scott asked, "May Q&As be included at the end of the Compass Youtube videos?"

Mrs. Agravante asked, "May Compass create a private YouTube channel for parent resources and recorded field trips?"

Mrs. Scott mentioned that she is really happy about the Weeks Of Welcome and thinks it was really helpful and asked, "Does Compass plan on recording the year's meetings?"

Mrs. Vanderwath also mentioned she hopes Weeks of Welcome continues yearly.

Ms. Vanderwath asked, "May we add the link into the MMU so everyone can have access to the staff emails?"

Mrs. Pugh mention, "Loving the addition of The Values this year as a front & Center awareness."

Mrs. Scott mentioned, "Would love chess and Minecraft as subscription too."
