Compass Charter Schools of Yolo (CCS) is a free, nonclassroom-based, public charter school which is directly funded by the State of California and the federal government. CCS of Yolo provides 21st century online and home study learning programs authorized by Winters Joint USD for scholars (students) in grades TK-12 who reside in Yolo County and its adjacent counties and wish to pursue high-quality, and rigorous instructional programs via virtual learning.

CCS of Yolo uses its federal funding to supplement instructional programs for its scholars. The processes that are in place to ensure funds from state and federal funds are used in a coherent manner to support achievement of the Compass mission, vision, and our core values of Achievement, Respect, Teamwork, Integrity, and Communication (ARTIC). The goals for all scholars are to remain transparent regarding all fiscal expenditures, especially state and federal funds. The Parent Advisory Council (PAC) will review and approve the Local Control and Accountability (LCAP) annually prior to submission to the Board of Directors for final adoption. The 2020-21 School Plan for Student Achievement (SPSA) has been developed to meet the federal requirements for this academic year due to the 1-year suspension of the LCAP as the result of the global health pandemic.

CCS of Yolo's scholar population is comprised of socioeconomically disadvantaged (33.20%) and English Learners (1.20%). CCS of Yolo makes it a priority to develop major actions in the SPSA to support all scholars, but especially scholars who are socioeconomically disadvantaged and/or English Learners and/or Foster Youth (0.20%). The overarching goals for CCS of Yolo include the following: Scholars will increase academic achievement, increase scholar retention and scholar and parent (learning coach) engagement and involvement, increase academic achievement and engagement for scholars in special populations to include English Learners (EL), Foster Youth (FY), Homeless Youth (HY), Socioeconomically Disadvantaged scholars (SED), and Students with Disabilities (SWD), and increase college and career readiness for scholars in high school.

The major priority areas at CCS of Yolo are personalization, blended learning, data-driven instruction, Multi-Tier System of Supports (MTSS), and supervising teachers (STs). The personalized learning model to the scholars includes virtual instruction and differentiated instruction for the scholars at their

instructional level during learning labs. Differentiated instruction may include the scholars working with tutors, working on an adaptive online learning program like Edgenuity, iStation, ThinkingStorm, or others.

The major actions included in the SPSA for all scholars are to improve academic achievement, scholar and learning coach engagement and involvement, focus on scholars in special subgroups and increase college and career readiness. The increased or improved services for socioeconomically disadvantaged scholars, foster youth and English Learners to improve proficiency include personalized learning plans, through the learning labs, access to MTSS strategies for support and interventions, tutoring by ST's and educational facilitators through support sessions and online through ThinkingStorm, learning lab materials, and online learning programs. The increased or improved services to provide access to state standards curriculum taught by appropriately assigned, highly qualified STs include meaningful professional development, administration and analysis of internal and external assessments, and new ST coaching and support. All STs will receive professional development sessions on curriculum, MTSS, Social-Emotional Learning (SEL), Positive Behavior Interventions and Supports (PBIS) in virtual instruction, writing and scoring constructed responses, data analysis and informing instruction, pacing guides, grading and communication with scholars and learning coaches, strategies for ELs, SWD, FY and HY, SED and culturally relevant proficiency. All of CCS of Yolo's instructional staff will attend the Advancement Via Individual Determination (AVID) Digital XP Conference, while some ST's and administrators will attend conferences like Digital Learning and Advanced Placement and CUE. One key aspect is to ensure attendance and incentivize attendance and participation which will increase retention of scholars in grade spans by supporting scholar and learning coach engagement. Learning coaches will have the opportunity to attend the Learning Coach Academy, serve as a Learning Coach Ambassador, and attend council and Board meetings. CCS of Yolo will make accommodations for learning coaches of scholars in special populations so every learning coach can participate. Moreover, CCS of Yolo will expand the Award Recognition Program to increase scholar and learning coach engagement. Extracurricular activities will include scholar clubs, workshops, transition meetings and online counseling sessions starting in grade 4 to support the social emotional well-being of scholars. Communication via Parent Square will continue to reach out to learning coaches and scholars to increase engagement with our weekly Monday Morning Updates, quarterly newsletter, the Compass Chronicle, and engagement slides in ST's learning labs and ST composed weekly newsletters.

In order to increase academic achievement and engagement for scholars in special populations including EL, SED, SWD, HY and FY, CCS of Yolo will provide enhanced identification with the continuation of its MTSS to support all scholars. Tier 1 includes all core instruction held in various subjects for all grade levels. These can include regularly scheduled grade level subject specific synchronous learning labs or specialized workshops offered to support a range of skills necessary for scholar success. Scholars qualified for receiving Tier 2 and Tier 3 supports are offered additional interventions using synchronous online small group or one-on-one tutoring sessions in conjunction with Edgenuity and iStation. Scholars qualify for Tier 2 and 3 supports based on data gathered through diagnostic assessments and observations by their instructional staff and Learning Coaches. Progress is monitored at regular intervals and referrals for additional assessments or interventions are made as needed. The scholars who are identified as English Learners will be supported in various ways, including live support sessions, appropriate assessments such as the ELPAC, strategic lesson design including research-based English Language Learning strategies, differentiated instruction, new ELD curriculum through Lexia, English learner focused synchronous online learning labs, and surveys to STs for additional support needs. Scholars with Exceptional Need (Section 504 Plans and Individualized Education Plans) will be supported by the Scholar Support Coordinator (SSC) and Special Education Department (SPED). The Scholar Support Coordinator will ensure the scholars with 504 Plans can access the general education program with the accommodations specified in their individual 504 Plan. 504 meetings are reviewed annually to ensure current needs

are being addressed. The SSC monitors and supports 504 scholars and families to ensure they have the accommodations in place in order to access the general education curriculum. The SSC also works with the Academic Services staff to monitor data and coordinate SST support meetings. Scholars with Individualized Education Plans (IEPs) are supported by the SPED Department. The supports vary depending on scholar needs as identified in their IEP and this includes an array of services determined by the IEP team. IEP meetings are held at least annually and reassessed triennially to ensure current needs are being addressed. CCS of Yolo's McKinney-Vento Liaison will continue to provide support to Foster Youth and scholars experiencing homelessness by connecting with their families at least quarterly to determine their needs and will continue to provide appropriate community resources to families as needed which may include but are not limited to childcare referrals, counseling referrals for scholars, earbuds, emergency shelter referrals, food and clothing resources, housing assistance referrals, and so much more.

To increase college and career readiness, the increased or improved services include access and connections to college preparation exams and preparation courses. In addition, middle and high school scholars work in conjunction with the Counseling Services Department to ensure they are meeting graduation requirements and are prepared for life after high school. Counselors map out a four-year plan for high schoolers and connect with each scholar to review and discuss the scholar's plan for meeting graduation and college-and career-readiness standards. Our College and Career Readiness Counselor regularly holds live sessions on topics such as concurrent enrollment, building a resume, and post-graduation options. Our school counselors continue to provide scholars with direct and indirect services to support their academic, social/emotional, and career development needs. Counselors have prioritized ensuring scholars have a sense of belonging, connection and support for academic success. Case Managers in our special education program continue to support scholars virtually through the delivery of their IEP goals. All high school scholars are given the option to enroll in a-g courses. The Accelerate Education curriculum is a-g approved, and utilized by scholars in both our Online Learning and Options Learning Programs. Options Learning Program scholars may also choose to take a-g approved courses using our adopted curriculum or approved curriculum from one of our approved community providers. The AVID program will be enhanced to support the scholars who are in special populations especially scholars who are nearly meeting standard mastery, the first in the family to attend college, and those without rigorous academic support at home.

The decisions made about the use of supplemental federal funds are discussed at the school level through the PAC. The council discusses academic performance, supplemental services and areas to make improvements with Title funds as part of the LCAP conversations at the first meeting in the fall and at the final meeting in the spring. The learning coaches also participate in an annual survey which provides feedback on the goals and services. The STs and staff actively participate in the decision-making process throughout the year and during LCAP workshops. The decisions take into account the needs of CCS of Yolo based on scholar achievement data which include SBAC, ELPAC, internal assessments, work completion and attendance and scholar demographic data to include the significant subgroups of Black or African American, Latino, White, Two or More Races, socioeconomically disadvantaged, scholars with disabilities, and English learners. This scholar achievement data and scholar demographic data is used as a basis for making decisions about the use of supplemental federal funds and the development of policies on basic core services.

The activities supported with federal funds will be evidenced by achievement data for all scholars, English learners, foster youth, socioeconomically disadvantaged scholars and low-achieving scholars. The SPSA goals were designed for all scholars to improve proficiency in key content areas of increasing academic achievement, increasing scholar retention and scholar and learning coach engagement and involvement, increasing academic achievement and engagement for scholars in special populations to include English Learners (EL), Foster Youth (FY), Homeless Youth (HY),

Socioeconomically Disadvantaged scholars (SED), and Students with Disabilities (SWD), and increasing college and career readiness for scholars in high school.

Compass Charter Schools (CCS) of Yolo's mission is to inspire and develop innovative, creative, self-directed learners, one scholar (student) at a time. Our vision is to create a collaborative virtual learning community, inspiring scholars to appreciate the ways in which arts and sciences nurture a curiosity for life-long learning, and prepare scholars to take responsibility for their future success.

CCS of Yolo supports its scholars, learning coaches (parent/guardian), supervising teachers (ST's), staff and community through our core values of Achievement, Respect, Teamwork, Integrity, and Communication (ARTIC). The mission is communicated throughout the Local Education Agency (LEA) by including it on the school's website, discussing it at staff meetings, learning coach meetings, and discussing it with scholars. The scholars know that they receive extra help from tutors, STs who care about them, and their learning coaches who are engaged at the school.

The processes that are in place to ensure funds from state and federal funds are used in a coherent manner to support achievement of CCS of Yolo's mission and vision and the goals for all scholars are to remain transparent in regard to all fiscal expenditures, especially state and federal funds. The Parent Advisory Council (PAC) will review and approve the Local Control and Accountability (LCAP) prior to submission. The PAC will receive quarterly benchmark data (internal assessments and attendance) for all scholars and significant subgroups to ensure that progress is being made and the achievement gap is being closed. CCS of Yolo will utilize the systems created to review what the scholars are doing, what the STs are doing, how the scholars and STs are interacting with each other and with the core content, and what the instructional content looks like. The teams will review work completion during learning periods, feedback provided to scholars, quarterly benchmarks, attendance rates, and personalized learning plans. The Leadership Team will implement specific reporting systems to collect these specific data points to monitor scholar growth and progress. As strengths are identified through these reporting systems and Professional Learning Communities (PLCs), the PLC teams will reflect on the factors that are making progress possible. As areas of opportunity for growth are identified, the PLC teams will reflect and evaluate the evidence-based strategies implemented to effectively promote academic growth and progress. Through the continued evaluation of these strategies, those which are not effectively showing scholars growth will be discontinued or replaced with evidence-based strategies and/or interventions. CCS of Yolo has a comprehensive Multi-Tiered System of Supports (MTSS) framework, supported by the Advancement Via Individual Determination (AVID) mindset, whereby scholars needing Tier 2 or Tier 3 support are invited to tutoring sessions to address math and reading skill gaps whereby tutors use supplemental curriculum through Istation and Edgenuity to address scholar needs. Scholars qualify for Tier 2 and 3 supports based on data gathered through diagnostic assessments and observations by the instructional staff and learning coaches. These can include regularly scheduled grade level subject specific synchronous learning labs or specialized workshops offered to support a range of skills necessary for scholar success. Tier 1 includes all core instruction held in various subjects for all grade levels. Progress is monitored at regular intervals and referrals for additional assessments or interventions are made as needed. The effectiveness is determined by course progress and improvement on supplemental assessments and benchmark data. Scholars will complete the diagnostic assessment three times a year to show

growth. After each diagnostic assessment, scholars will be assigned to a specific Individualized Learning Plan (ILP) tutoring group and will complete the ILP curriculum to close skill gaps in reading and math. The STs will monitor scholars' completion of these assignments, tutoring attendance in reading and math, curriculum completion, and growth through data analysis of each assessment. The Assessment Coordinator will collect and disseminate the data from each diagnostic assessment to the STs, Scholar Success Coordinator, and tutors. Tutors under the MTSS framework will provide targeted, 30-minute synchronous sessions that target specific skill gaps, as indicated in the diagnostic assessment and ILP supplemental curriculum to provide additional support and instruction to address needs. The LEA will monitor the effectiveness and implementation of this program by collecting specific data of at-risk scholars determined through diagnostic assessment tier identification and academic progress to meet standards and close skill gaps from the supervising teachers bi-monthly. Likewise, the LEA will collect and share data collected from the Scholar Success Coordinator that will show scholar growth through diagnostic assessments, ILP course completion, and tutoring participation. Each learning coach will receive updated progress information about the academic growth of his/her child every eight weeks. The Superintendent will present the scholar achievement data quarterly for all subgroups and significant subgroups to the Board of Directors. This process ensures that the state and federal funds are used in a coherent manner.

The scholar group data drives decision-making about the use of state and federal sources because the scholars with the greatest need in addition to the scholars who are identified as at-risk are the scholars who generate these funds. As the stakeholders meet to determine the schoolwide goals, it is the review of scholar achievement data which determines the types of activities that should be provided to increase scholar achievement. The annual achievement results of scholar group data help the stakeholders to determine which activities were effective in the prior year, and which activities need to be expanded, changed or replaced. This is a powerful process of continuous improvement. It is imperative to utilize these funds to supplement and enhance the core program so there are instances when the core program has evolved to better provide the basic program.

The processes in place to ensure that activities funded from various state and federal sources are not duplicative and support common outcomes are designed to enhance the basic program. The core program has been developed to provide high quality, standards-aligned curriculum to all scholars. The PAC, ST's, staff and learning coaches provide input on the core program, then make decisions based on differentiated needs of the scholars based on scholar achievement data and scholar demographic data. This ensures that the activities are not duplicative, yet support the common outcomes.

The information about the school and organization's priorities are communicated to stakeholders include posting on the website, holding LCAP workshops for families, notifying parents of Title I programs in the Scholar Handbook, reviewing and approving the LCAP at the PAC, discussing the LCAP goals a minimum of quarterly with ST's and staff as they begin to review scholar achievement data, posting the annual LCAP with the Federal Addendum on the website, reviewing the monthly financial reports at a regularly scheduled Board meeting, and listing it in the Annual Report.

CCS of Yolo ensures that school plans are aligned with the goals and priorities by reviewing the LCAP and the Federal Addendum with the PAC. Learning Coaches serve as executive officers on the committee and receive annual training on their duty to develop the LCAP, approve the federal restricted funds, approve the LCAP and Federal Addendum, and allow the learning coaches to propose suggestions and questions.

Compass Charter Schools (CCS) of Yolo develops and evaluates the Title I Parent Engagement Policy by engaging with the learning coaches during Coffee with Compass, quarterly Parent Town Halls, and the Parent Advisory Council (PAC). Developing the Parent Engagement Policy is aligned to the process with the LCAP stakeholder involvement process as evidenced by frequent meetings with learning coaches (parents), sharing the development of the policy and the LCAP with the PAC.

CCS of Yolo provides the Learning Coach Academy for all new learning coaches. Learning Coaches attending the Learning Coach Academy attend workshops on Understanding State Standards and assessments including SBAC and ELPAC, Title I Parent Rights Meetings, How to Help your Child be Successful, Accessing the Online Learning Tools, How to Prepare for Parent Conferences, Preparing for College and Career, and Social-Emotional Learning. CCS of Yolo provides materials during these

workshops in both English and Spanish. CCS of Yolo also engages learning coaches by honoring the academic success of each scholar's individual goals and celebrations of academic achievements, academic growth, regular attendance, and scholar of the month at award recognitions.

CCS of Yolo provides meaningful professional development to administrators, STs and staff on building learning coach relationships and valuing learning coaches as partners. This has included working with staff to develop meaningful opportunities at the school for learning coaches to include completing Learning Coach Academy sessions, volunteering for events, chaperoning field trips and serving as learning coach ambassadors.

CCS of Yolo integrates learning coach involvement as leaders by encouraging, but not requiring, Learning Coach Partnership Hours. Learning Coaches can satisfy their Partnership Hours by participating in academic achievement (i.e. Learning Coach Academy, teacher conferences, serving on a committee or council), school community (i.e. attending community meetings, helping and attending special events, chaperoning field trips), and education advocacy (i.e. attending Parent Leadership meetings or school hearings). All information about learning workshops, programs, meetings and activities are posted on the school's website, schoolwide emails and phone calls, newsletters and reminders in English and Spanish. CCS of Yolo will add another language as the need arises. CCS of Yolo makes accommodations for learning coaches with disabilities and learning coaches of migrant scholars so that they can actively participate in the school which includes home visits. CCS of Yolo will focus on scholar learning, individual goals for the scholar and investing in families especially learning coaches with disabilities and learning coaches of migrant scholars. Compass Charter Schools (CCS) of Yolo provides programs and services to the scholars including personalization, blended learning, data-driven instruction, Multi-Tier System of Supports (MTSS), and supervising teachers (STs). The personalized learning model to the scholars includes virtual instruction and differentiated instruction for the scholars at their instructional level during learning labs. Differentiated instruction may include the scholars working with tutors, working on an adaptive online learning program like Edgenuity, iStation, ThinkingStorm, or others. These schoolwide services support academically at-risk scholars by increasing literacy and numeracy skills by increasing ELPAC

scores to 3 or 4 for English Learners, SBAC ELA scores, SBAC Math scores and graduation rates. The importance of increasing these scores ensures that scholars are meeting or exceeding grade level mastery which helps close achievement gaps. Title I funds used for MTSS curriculum and tutors support scholars who are at risk of not meeting state standards. During learning labs, scholars engage in collaborative activities guided by the STs. CCS of Yolo also receives support from our Scholar Success Coordinators and our English Learner Support Coordinator to support and monitor the growth of scholars.

The Parent Advisory Council (PAC) works diligently to review scholar achievement and make recommendations for services like online tutoring, ensuring the Principal monitors the implementation of math curriculum scope and sequence, and differentiated math groups to provide small group instruction during support sessions. The PAC completes an annual needs assessment in the development of the annual Local Control and Accountability Plan and reviews the effectiveness of the prior year plan in order to determine which services should continue, change or be replaced.

CCS of Yolo is committed to providing a high-quality education with all the support necessary to ensure that youth experiencing homelessness have the opportunity to succeed. In order to help youth experiencing homelessness, the McKinney-Vento Liaison will assist in procuring referrals to health, dental, mental health, substance abuse services, housing services, and any other appropriate services. The McKinney-Vento Liaison will assist the learning coaches with enrolling the scholar, obtaining necessary immunizations or immunization records. The McKinney-Vento Liaison will encourage learning coaches to be involved in their child's education and ensure that learning coaches are informed of educational and related opportunities to assist their child to be academically successful. CCS of Yolo provides loaner laptops and mobile hotspots to scholars that do not have access to devices and consistent internet access. Technical support has been offered through our ZoHo Helpdesk, which provides scholars assistance using their devices, connecting to the internet and accessing their classes/curriculum.

CCS of Yolo recognizes that children learn attitudes about school from the learning coaches; therefore, as learning coaches are excited, positive and supported by CCS of Yolo, the child's transition to school will be smooth. CCS of Yolo hosts an Orientation, Transition Meetings, Parent Conferences, events and activities, and multiple events like Learning Coach Academy, Scholar Leadership Council, Parent Advisory Council and onboarding support.

Compass Charter Schools (CCS) of Yolo provides a strategic plan to onboard new supervising teachers (ST's) as well as a plan that provides professional growth and improvement for current ST's, staff, and administrators. All CCS of Yolo ST's and staff take part in professional development activities which include summer training that emphasizes foundational knowledge in CCS culture across academic programs and departments. CCS of Yolo provides training in effective planning, including daily lessons, units, and yearlong plans. In addition, the program in the summer introduces foundational components of the CCS of Yolo's program which is especially helpful for new STs, including the use of data, instructional techniques, and the scope and sequence of curricula. All staff complete annual required training including mandated reporter training. New STs will be offered to clear their credential through an Induction Program, a veteran ST who will serve as a mentor and support meetings once a week for the first month, then once a month for the first 5 months. All STs will be provided professional development sessions on curriculum, Multi-Tier System of Supports (MTSS), Advancement Via Individual Determination (AVID) Social-Emotional Learning (SEL), Positive Behavior Interventions and Supports (PBIS) in virtual instruction, writing and scoring constructed responses, data analysis and informing instruction, pacing guides, grading and communication with parents and learning coaches, strategies for ELs, SWD, FY and HY, SED and culturally relevant proficiency. Some STs and administrators will attend conferences like the CCSA Conference, CUE Conference, Digital Learning Annual Conference, AVID National Conference and Advanced Placement. The professional development sessions are differentiated by subject, grade, program and focus on skill-building to maximize ST time. Scholars benefit from this higher-level professional development that their teachers receive.

CCS of Yolo builds leadership capacity of STs, principals and school leaders by providing opportunities for STs to facilitate professional development sessions for other STs, mentoring new STs and ST leaders who are interested in administration, and providing additional professional development previously mentioned beyond the sessions provided by CCS of Yolo. The administrators attend workshops like "Effectiveness through Understanding," "Communication and Collaborative Problem Solving," and "Staff Motivation and Development." Also, administrators attend an intensive series of workshops on topics like instructional coaching including observation and feedback, data driven instruction, and providing meaningful professional development.

CCS of Yolo dedicates time throughout the school year for staff professional development. The Assistant Superintendent and Chief Academic Officer ensures participation by verifying sign-in, and most importantly, observing strategies during Learning Labs, analyzing data and determining that professional growth is occurring and improvements in ST capacity and scholar achievement is realized. The Assistant Superintendent and Chief Academic Officer will make adjustments to the professional development sessions to ensure continuous improvement.

The use of data and ongoing consultation is a cornerstone of Compass Charter Schools (CCS) of Yolo. Learning how to better utilize data enables supervising teachers (STs) to improve instructional practices and better serve all scholars. CCS of Yolo examines data a minimum of four times per year to review a variety of internal and external assessments to determine progress and areas of opportunities. These assessments include: cumulative assessments four times per year, internal assessments three times per year, attendance, graduation rates, and the annual SBAC and ELPAC assessments. During data analysis, with the support of the Assessment Coordinator and Assessment ToSAs, the administrators help STs analyze their scholars' assessment data to identify areas of common areas of opportunities. Finally, the STs then revise lesson plans to focus on the areas of opportunities. The Leadership Team assesses the impact of these data analysis. Since data analysis is scheduled a minimum of four times per year, the progress is measured frequently. The foundational piece of the ongoing professional development is customized, targeted one-on-one coaching provided by the Assistant Superintendent and Chief Academic Officer to all STs. This helps all STs better instruct all scholars, including English Learners and scholars with disabilities. Moreover, CCS of Yolo has developed time for content and grade level collaboration including STs and administrators in order to make rapid movement based on recent data to achieve academic goals and address school culture needs. Other stakeholders are aware and supportive of this process and review the positive growth that this professional development model achieves. This process ensures that the uses of Title II funds are based on data-driven decisions which work in coordination with other funding and programs supporting scholars' academics, social-emotional wellness and personal success.

Compass Charter Schools (CCS) of Yolo developed this Federal Addendum in consultation with learning coach (parents) leaders during Parent Advisory Council (PAC) meetings, supervising teachers (STs) during professional development sessions, with scholars (students) during Scholar Leadership Council (SLC) meetings, and with the Leadership Team reviewing the most common strategies or obstacles to success. All stakeholders which includes STs, learning coaches, scholars, staff and administrators complete an annual needs assessment in the development of the annual Local Control and Accountability Plan and review the effectiveness of the prior year plan in order to determine which services should continue, change or be replaced. One benefit that CCS of Yolo experiences is being part of the Charter Management Organization of Compass Charter Schools which allows the individual schools to collaborate on supports and resources needed.

CCS of Yolo is committed to an engaging and supportive learning environment that supports academic achievement through social-emotional learning (SEL) and safety training. CCS of Yolo follows a rigorous calendar of staff training, safety team meetings and professional development. In order to ensure that the scholars are safe and healthy, CCS of Yolo has implemented powerful Positive Behavior Intervention and Supports supported by the counselors. The SEL supports have been found to decrease suspension rates, prevent violence, and increase self-esteem and self-regulation. In addition, CCS of Yolo has hired Scholar Success Coordinators to ensure the scholars get the support they need. The long-term benefits of this support will include drug and violence prevention, suicide prevention, conflict resolution and fewer mental health issues caused by trauma.

CCS of Yolo incorporates homeschool and virtual platforms to provide the core curriculum and use additional online platforms to provide targeted instruction for the scholars. The benefit of using technology like this supports each scholar at his/her own level. It provides another format to ensure the core curriculum is differentiated in a way that support the scholars' interests, allows them to interact with the platform individually at his/her own level and provides digital texts that can define words, allow scholars to take notes or refer to the text, it also reads it to the scholar (text to speech) and alerts the scholar of any misspellings. The goal of using technology to supplement the core program ensures that personalized instruction is provided.
