The Online Learning Program K-5 supplemental materials have been ordered and accounts for Online Lakeshore kits have been placed for families to utilize throughout the school year.</p> <p>All scholars enrolled in our Options Learning Program have access to numerous community providers who supply core curriculum and use our ordering system, Online Purchasing Systems (OPS), with curricula shipped directly to the families. Our supervising teachers (STs) review the orders to ensure that appropriate core curricula are ordered through our Community Providers Department. Scholars also have access to online curriculum via Freckle. Scholars in grades K-12 have access to Freckle from Renaissance in all core subject areas.</p> <p>The Special Education Task Force for moderate/severe scholars has been working on identifying resources and curriculum that will provide access to Common Core.</p>

These are delivered weekly to grades 4th-12th. SEL and scholar well-being supports/interventions are also provided directly to scholars during individual scholar counseling sessions as well as with responsive services.</p>

For classified staff, supervisors onboard the staff member utilizing the training schedule template and checks in with the staff member on a regular basis. This is done in conjunction with our People Division (Human Resources). Our Training & Development Manager has been conducting 30-day check-ins with all new staff. Survey links have been sent out and she will also schedule a meeting with our new hires to inquire about their first 30-days here at Compass. We are hearing great things so far and hope to continue to receive</p>

Update	The Staff Support Team has led numerous professional learning sessions in August and September, and added the recordings and resources for staff to peruse on the Staff Support Guidesite. The team has also been curating/vetting resources that will be added to the professional growth plans "resource banks" in an effort to support the Academic Support lead measure monthly goal. The Staff Support Team has started planning for our first In-Service Day and have been brainstorming topics to present. The Director of Staff Support is working with our partner, Learner-Centered Collaborative, to finalize the Wednesday cadence details for the personalized pathway in order to group supervising teachers accordingly, and to their learning preference.

Update	<p>Our Training & Development Manager has partnered with the Director of Staff Support to create and deliver a series of professional learning opportunities for supervisors. So far three of these workshops have been delivered. The first workshop, The Transition to Supervision, was delivered on Thursday, August 11. The second workshop, Coaching the Compass Way, was delivered on Tuesday, August 30 for supervisory staff. And, the third workshop, Growing Your Mindset and Seeing Each Other in a New Way, was delivered on Wednesday, September 21. This workshop was a stepping stone in working towards meeting our Wildly Important Goal #1 - 100% of staff will report increased coherence, improved culture and greater connectedness by the end of the 2022-23 school year!</p> <p>Compass has continued their partnership with Learner-Centered Collaborative to provide our staff in leadership positions (coordinators and above) bi-monthly mentorship sessions. During the month of September all coordinators and above had their initial mentorship meeting with their Learner-Centered Collaborative mentor.</p> <p>Members of the leadership team, including supervisors, received an invitation to complete the SDI 2.0 Core Strengths assessment via the online portal and had until 5:00 pm on Friday September 16 to complete the assessment. This assessment will help our staff in leadership positions gain a fresh insight into managing their strengths and deploying them more effectively to better serve the needs of our staff and/or scholars. We will be leveraging what the staff learns from their assessments during our monthly Leadership Pathways.</p>

Update	<p>The Operations Department has created an identification process during several points of enrollment. When a new scholar is imported into the student information system, the Enrollment Team checks that scholars have been identified properly as English Learners or to be determined, McKinney-Vento, or Foster Youth/Tribal Foster Youth. A notification flag is sent to specific departments that would then be able to support the scholar by identifying appropriate resources or programs based on the scholar’s needs. The Enrollment Team also identifies scholars who may be in need for assistance with a laptop or internet access through the Reg Online application. They identify the need on the scholar’s dashboard in the student information system. This helps refer scholars/ families to our computer loan or internet reimbursement programs.</p> <p>Once a scholar has fully enrolled with a signed master agreement, the Household Data Collection Form or Alternative Income Survey Form is distributed via email to the families within the student information system. Once these forms are signed and submitted by the families, the Compliance Team reviews for completion and imports the data into the scholar’s records within the student information system. When this is completed, an indicator on the scholar’s dashboard appears to notify if they are National School Lunch Program eligible. These indicators are essential for staff to determine a scholar’s eligibility for several resources or programs internally and externally. Internally, these indicators may help determine priority for our computer loan or internet reimbursement programs. In addition, the indicators assist our Orange County Learning Center coordinators determine which scholars are eligible for Free and Reduced lunch so that they may provide a school breakfast or lunch during the two-day program. Externally, it may help a scholar qualify for fee waiver for an AP exam or college entrance exams such as Scholastic Achievement Test (SAT) or American College Testing (ACT). The Compliance Team also downloads and reviews Direct Certification reports from CalPads to assist identifying scholars who may be eligible for Free or Reduced lunch through the state reporting system and local county social services agencies.</p> <p>The Scholar Community Advocate reviews all Housing Questionnaires during enrollment and collaborates with enrollment specialists to assess for McKinney Vento eligibility for all new scholars. Scholar Community Advocate assists families during transition by answering enrollment questions, connecting families with an</p>

	<p>enrollment specialist and requesting records when necessary to help place scholars during the admissions process. Connects scholars and families with internal and local community resources. A process is in place to document all resources, services, or referrals in Contact Manager. The Scholar Community Advocate assists and supports scholars and families when they need the following internal resources: computer loan program, internet reimbursement program, earbuds, records transfer (postage, etc.), help getting birth certificates, immunization records, connect me with a school counselor, help with transcripts, help with FAFSA or college questions, referral to Compass tutoring services, and more.</p> <p>The Scholar Community Advocate assists and supports scholars and families when they need the following community resources: emergency/temporary shelter, food banks/meals, medical referrals/services, mental health/counseling referrals/services, drug & alcohol substance abuse programs/referrals or services, career services, dental referrals/services, hygiene programs, housing referrals/services, domestic violence abuse referrals/services, clothing and shoes necessary to participate in physical education classes, information on head start programs.</p>
On Our Docket	<p>The Operations Department will continue accepting and processing enrollment applications, as well as flagging departments through the contact manager to quickly alert the status of new special populations enrollment. Our Compliance Department will continue to oversee the Household Data Collection and Importing through October 31 and Direct Certification continues through June 30. Our Scholar Community Advocate will continue to monitor and review incoming housing questionnaires to quickly identify new McKilney-Vento scholars.</p>

Update	<p>The Learning Coach Academy (LCA) for the 2022-23 school year was launched in September. LCA is a resource for our learning coaches that provides them with the tools for success. LCA meets weekly live via Zoom on Mondays at 11 am, and sessions are focused around learning coach requested content and social opportunities. All learning coaches who register are added to a Learning Coach Academy ParentSquare group where they discuss LCA topics. Learning coaches who are unable to attend the LCA sessions or do not register for the program are able to access the recordings via the Monday Morning Update (MMU).</p> <p>Our Orientation Coordinator created the LCA job aid to support the staff members who have signed up to host LCA sessions for the 2022-23 school year. The job aid has been shared with those who signed up to host an LCA session.</p>

Update	<p>Our Summer Session took place July 5-29. Families were given the choice to take art class through Accelerate Education and participate in two Summer Session subscriptions. A total of 129 families signed up all together, while 32 families signed up to only participate in Summer Session subscriptions. Scholars in grades K-5 participated in art development courses while scholars in grades 6-8 participated in basic drawing and beginning painting through Accelerate Education.</p> <ul style="list-style-type: none"> ● 65 scholars signed up for the K-5 art development courses ● 33 scholars signed up for basic drawing or beginning painting <p>Of these scholars, 66% percent completed their Accelerate Education art course. Along with the Summer Session subscriptions and Accelerate Education art courses, scholars were able to participate in weekly, live sessions with the K-8 Summer Session supervising teachers. An average of 50 scholars attended these sessions each week during the summer.</p>
On Our Docket	A survey has been sent out to the families who participated in our Summer Session. Once the survey feedback is collected, we will make a determination regarding the efficacy of the Accelerate Education art courses. Our team will look into targeted subscriptions and live sessions to best utilize resources for the 2022-23 Summer Session.
