A. Finance Committee Updates

Greg Thompson:

Cash Balance: \$1.94M in cash in the bank with \$1.04M coming in from BEP payments in the next few days (~84 days of cash). Cash will decrease in May and July, which are months the organization does not receive BEP payments. Projected to end year with just over \$2M in cash.

FCS applied for a forgivable loan from the SBA program (part of federal stimulus) through SunTrust / Truist. The allowable requested amount was \$1.5M (based on average monthly payroll). Very likely that FCS will receive allocation which will be used for payroll costs over the next 3 months.
