MA reviews the budget for 24-25. MA performed a budget line analysis, aligned on a timeline and tasks, had an in person work session with MR and 4th sector and is working with everyone to complete budget. MA reviews budget timeline. SR discusses how our per pupil rate has come in the last few years. 4th sector projects the per pupil increase will be 3.8% for the year. Salaries for the school is correlated to the per pupil rate

increase. MR explains that salary is based on market analysis. KB asks how we perform the analysis. MR explains that 4th sector does an analysis and also looks into NYC DOE. SP asks about increase for this year and the projection is 3.5 for salary increases. SP asks about fundraising, and MR mentions that it has not been worked into a model.
