## **II. Committee Business**

### **A. Expansion Update**

MR reviews budget numbers and different scenarios that impact P&L. The building owners want to have access to the gym space and we are creating different proposals that impact profit and loss. SP asks what percentage of the building is complete, MR responds we do not have those numbers, but we do know the building will be complete in August. SP asks if this timeline is best case and MR responds this is their on time scenario. MR also states concerns are related to the unknowns that exist with current timeline. SP adds that timeframe for completion is a cause of concern for her since the gym at current building took a long time. MR responds that the staff we have in place should mitigate that concern. SP asks if having enough teachers is concerning and MR

responds we are in a good space and may only need to add a few teachers. AB joins the meeting. MR updates that there are a lot of unknowns that are causing concerns.
