## III. School Update

### A. Update from Executive Director

MR, shared the following;

- K-8 Staff Attendance Breakdown
  - Throughout our 21 day period, 9.59% of the lower school staff were tardy, based on a total staff count of 55 (116 total late occurrences).
  - In our 21 day period, 2.64% of the lower school staff were absent (32 total absences).
- 9-12 Staff Attendance Breakdown
  - Throughout our 21 day period, 14.94% of the high school staff were tardy, based on a total staff count of 28 (92 total late occurrences)

- In our 21 day period, 5.19% of the high school staff were absent (32 total absences).
- K-8 Scholar Attendance
  - Student attendance had the highest rate at 92.62% on September 10 and the lowest at 85.69% on September 2. Despite minor dips during the month, attendance remained strong overall, showing consistent participation and engagement throughout September.
- High School Scholar Attendance
  - Student attendance had the highest rate at 87.65% on September 30 and the lowest at 76.23% on September 23. Despite some dips during the month, attendance improved toward the end, showing stronger participation.

- This F&P cycle showed overall growth across all grades. Last year ended at ~45% on/above grade level (EOY), and this year is on track to surpass that with ~65% on/above at BOY.
