## SUBJECT: 2018 FORM 700 FILING REQUIREMENTS

Dear Charter School Governing Board President and Charter School Leaders:

Filing a Form 700 - Statement of Economic Interests (SEI) is a state-mandated requirement for individuals who make decisions or advise on decision making at any government agency in California. The requirement is part of the Political Reform Act enacted in 1974, which was passed by California voters to promote integrity in state and local government by helping agency decision makers avoid conflicts between their personal interests and official duties. Under the Act, these individuals are required to disclose assets and income, which may be materially affected by their official actions.

The Fair Political Practices Commission (FPPC) has determined that a charter school constitutes a "local government agency." As such, a charter school leader, board members, executive director, chief executive officer, director, principal, assistant principal, coordinator, businesss manager, financial manager and consultants are subject to the same conflict-of-interest and disclosure requirements as any other public agency. Unless lawmakers and/or the courts clarify otherwise, we are abiding by the FPPC's guidance in the spirit of good ethics and have incorporated this disclosure requirement into the LAUSD Charter Policy and the LAUSD Conflict of Interest Code.

## California law requires these designated individuals to file a Form 700 as follows:

- (1) First assume position (within 30 days)
- (2) Annually while on position (due every April 1<sup>st</sup>)
- (3) Leaving position (within 30 days)

## First-time filers should remember these key points:

- Filing is easier than it may seem at first. The Form 700 is notoriously thick and intimidating in appearance, but for a large majority, filing is as simple as completing the cover sheet (especially if your finances are not complex).
- Do not delay. The Charter Schools Division is required by law to report violations of the Act to the District Attorney or the Fair Political Practices Commission, and violators can face financial penalties and/or sanctions.
