Specifically, Mr. Filidor shared various tips for families which included attempts at reading during informal moments, through everyday chores and holiday events. En general, el Sr. Filidor explicó que el objetivo es que los estudiantes interactúen con la lectura durante las vacaciones de invierno para continuar con las rutinas que les permitieron practicar la lectura en inglés.
