II. Academic Excellence

A. Mid-year Data Review

NWEA, a computer assessment the students take in reading in Spanish, English, and math.

Reports will tell the teacher if the child is on, above, or below grade level. Assessment is given three times a year.

NWEA is not a diagnostic assessment and is it the best assessment to inform teachers so that they can change instruction to meet the needs of the students.

Math Data

K, 2 took the assessment in Spanish

1, 2, 4, 5, and 6 met growth targets

ELA

K students do not have growth data because they did not take it in the fall.

1, 2, 4, 5, and 6 met growth targets

Projections on Math PSSA Data

The percent projected to score proficient and advanced is lower than last year.

Projections on ELA PSSA Data

The percent projected to score proficient is similar to last year.

Spanish Reading Levels using F&P, EDL

Only measures reading and does not measure Spanish literacy. It is not a diagnostic assessment.
