# II. CFO Financial Report

# A. March 2025 Preliminary Financial Report

Finacial report given by Eric Smith, CFO.

# • Financial Statements -

- Monthly Income is \$1,053,008; Budget was \$947,083
- Monthly Expense is \$894,0151; Budget was \$932,977
- Monthly surplus is \$158,993; Budget surplus was \$14,105

# • Budget -

- Budget for March was \$14,105 actual is \$158,993; this is a surplus of \$144,888
- Budget for FYTD was \$135,149 actual is \$991,315; this is a surplus of \$856,166
- Cash Flow -
  - $^\circ$  112 days of cash on hand

Dr Owes noted that we are holding on to more cash than normal as we are being mindful of future funding cuts. Asked Eric to look at the budget so we can present an amended budget during the May meeting.

Also noted that there is no update related to our Title 1 status. Requested a meeting with Fulton County but haven't heard back.

# A. ED April 2025 Report

- PTO Financial Report
  - \$74 in membership dues collected
  - Made a \$500 donation to the golf tournament.
  - Will sponsor events for teacher appreciation.
  - Will have low funds going into the next school year.

- Current ending balance = \$4,650
- Sale of Property Update
  - Buyers would like to go back to 1 acre vs 2 acre because of unusable parts of land A creek will make it difficult to build on one of the acres. We don't want to offer another part of the land that would make it difficult to expand in the future.
- Teacher Retirment TRS Employer Attestation Audit is currently underway. Executive Team and HR is working with Marshall Jones to complete.
- Fundraising
  - Tournament is this Saturday. 9-2PM
  - Still seeking sponsors, donors, players, and volunteers.
  - Thank you to our many sponsors.
  - $\circ$  Golf Tournament has raised roughly \$10k so far.
  - Admin will turn this fundraiser over to the Governing Board next year.
- Facilities
  - Another bathroom renovation has been completed with state facilities grant funds.
- Title IV Grant Funds-Flight Simulators
  - FCS has awarded TMSA additional Title IV Grant Funds to purchase additional flight simulators for our aviation program (approximately \$35,000).
