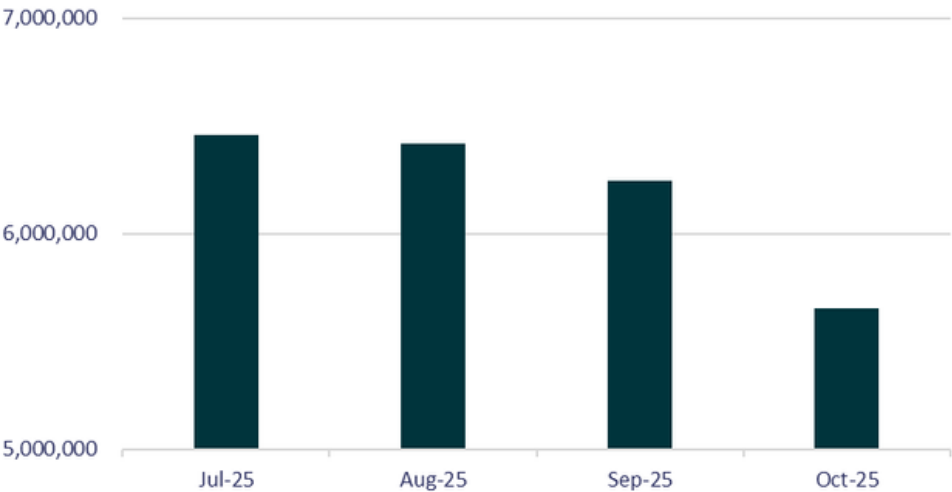

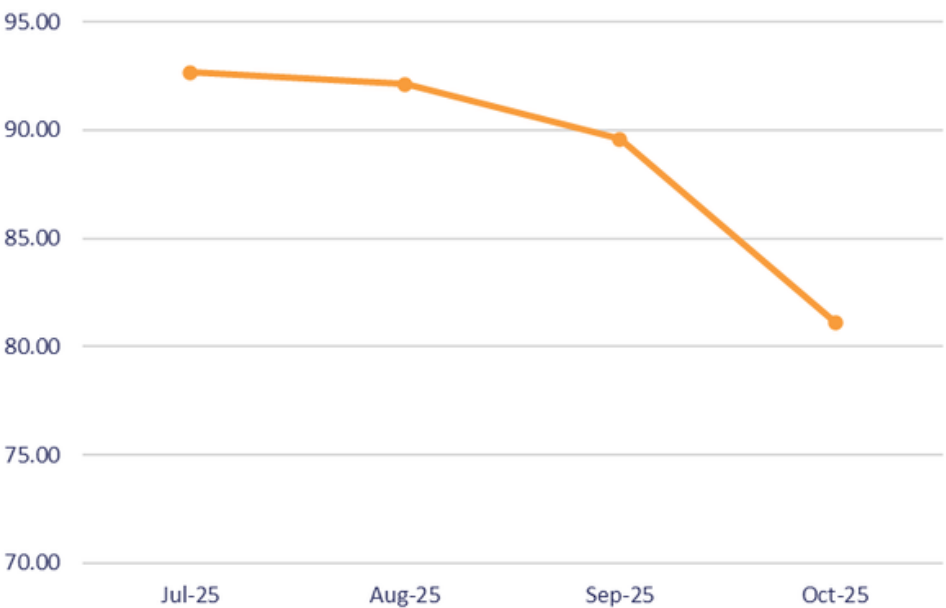

BALANCE SHEET

- Total Cash Balance of \$10,272,789, with an unrestricted operating balance of \$5,656,441.
- Accounts Receivable Balance of \$636,579 for grant draws.
- Prepaid Expense balance of \$464,656.
- Accounts Payable balance of \$479,813.
- Payroll Accrual of \$453,997 for October payroll paid in November.
- Accrued Bond Interest of \$782,038 for interest payments paid in January 2026.

BUDGET VS ACTUAL

- Revenue Recognition
 - Local Revenues: \$126,320 related to Food/Spirit Store, Athletics/Clubs, Building Rental, Donations, Erate Credits, & Class Fees
 - State Revenues: \$2,809,980 related to PCFP, ELL, FRL, Local Special Ed, CTE, State Transportation, & GATE
 - Federal Revenues: \$28,442 for IDEA B & Title I.
 - Earned Interest: \$20,016.
- Total recognized expenses are around \$2.2mm for the month of October, with approximately \$1.4mm of that being payroll related.
- All remaining expenses were related to normal operating costs of the school including supplies, purchased staffing services, utilities, debt related expenses, and depreciation.

OTHER NOTES

- There were some staffing adjustments over the summer, resulting in payroll being coded to accounts that don't currently have a budget. We will be making adjustments to these unbudgeted accounts in this month's budget amendment.

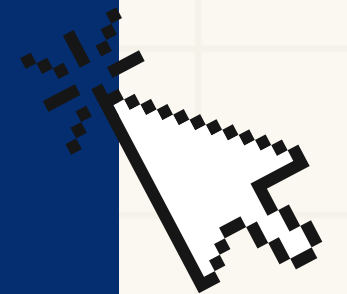

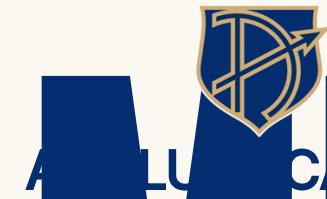

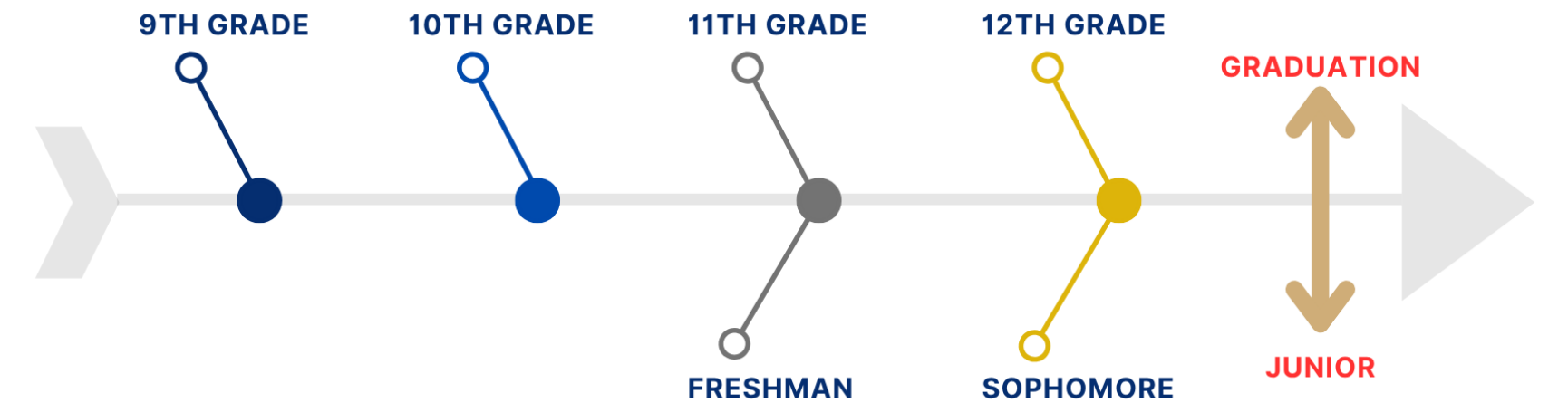

➤ IS DUAL CREDIT AVAILABLE FOR 10TH - 12TH GRADE, OR JUST 11TH - 12TH?

The program begins in 10th grade. The students in 10th grade begin with one class in the fall titled ALS (Academic Life Skills) 101 for three college credits at Amplus Academy. Then, in the spring, they will select one of six elective college classes online while still at Amplus Academy. Students can join at any year.

➤ WHAT ARE THE MINIMUM REQUIREMENTS?

Minimum 2.5 GPA (recommended), credit sufficient, decent CERT scores, no behavior issues, nor attendance issues. If you are currently enrolled in a CTE course, you must complete the program.

➤ DO MOST AMPLUS STUDENTS TAKE CSN CLASSES ON CAMPUS AT AMPLUS, ONLINE THROUGH CSN, OR IN PERSON AT A CSN CAMPUS? (OR A MIX?)

It is a mix. Only in 10th grade will they complete classes at Amplus. During 11th and 12th grade, students will be off Amplus campus and will take classes through CSN. Students have the autonomy to choose how and where they want to learn. For example, a student may enroll in their English 101 class in person at the Charleston campus, then take their History 101 class online. Students should decide how to enroll in their CSN classes based on how best they learn and what works best with their parents and their mode(s) of transportation. *CTE level II, competition performance groups, and StuCo remain on Amplus' campus.

➤ DOES AMPLUS COVER THE COST OF TUITION?

Yes, Amplus Academy will pay up to 15 credits.

➤ DO FAMILIES PAY FOR FEES / BOOKS?

Amplus Academy will pay up to \$250 for textbooks (online text or physical textbook).



AMPLUS ACADEMY

➤ DO STUDENTS NEED COUNSELOR APPROVAL BEFORE APPLYING?

The first step for Amplus Academy students will be to let their counselors know they are interested and then their counselors will let the AIA (Acceleration Institute of Amplus) Coordinator, Mrs. Viv Garner know.

➤ IS THERE A SIGNATURE FORM FROM PARENTS?

Yes, there is a handout with a checklist that parents then sign. Parents/Guardians will then meet with Mrs. Garner to review the responsibilities and expectations of AIA Dual Credit.

➤ DO THEY REGISTER THROUGH MYCSN AFTER BEING APPROVED BY THE SCHOOL, OR DOES THE COUNSELOR HANDLE ENROLLMENT?

The student will complete the MyCSN application once they meet with the AIA Coordinator and discuss the expectations of AIA Dual Credit.

➤ JUMPSTART VS DUAL CREDIT, AT YOUR CAMPUS, ARE THESE USED INTERCHANGEABLY, OR DO YOU DISTINGUISH THEM?

Jumpstart = in-person with an Amplus teacher on CSN credit - ALS 101
Dual Credit = taken with CSN faculty online or on a CSN campus

➤ ARE CSN CREDITS WIDELY TRANSFERABLE TO MOST U.S. COLLEGES?

CSN credits will transfer to any in-state NSHE accredited school, WUE schools, and most other universities. For non- Nevada schools, the best way to check if CSN credits will transfer is through the website *Transferology*. AIA supports include instructions on how to college plan!

BACKGROUND: An approved amended budget is required by the SPCSA and NDE in order to have access to the AB398 teacher raise money. Additionally, when moving forward with financing for the expansion, to include the athletic field, it is ideal to have a budget that is more accurate in terms of enrollment and cash position. Mast financial has included a comprehensive narrative of all items that have been updated in regards to revenue and expenses.

Please see the second document for MAST explanations of changes.

RECOMMENDATION: To approve FY26 Amended Budget



Amplus Academy 25-26 Amended Budget Summary

The audited 24-25 Fund Balance of \$10,853,156 is available to appropriate into this 25-26 amended budget. Significant adjustments are listed below:

Revenue:

- PCFP revenue was updated for 25-26 enrollment of 2,440 students. This is a decrease from the original budget of 132 students.
- State and Federal grants were updated for actual 25-26 allocations and any 24-25 carryover amounts.
- State Transportation allocation increased to \$1,137,565.
- Received AB398 funds of \$623,000 that will be used to cover staff raises and anticipated PERS costs.
- Received ERC refund of \$2,371,602 for Employee Retention Tax Credits for payroll paid in Q1 and Q2 of 2021.

Expenditures:

- Staffing was updated to reflect actual staffing for 25-26 and additional AB398 costs as part of that grant monies received. Overall, staffing increased from the original budget in the amount of \$161,214.
- Increase in Outsourced SSS Instruction staff of \$154,426 for shifts in current and outsourced staff.
- Increase in Tuition to Post Secondary costs of \$84,500 for the dual enrollment program.
- Increase in Professional Development of \$70,000 for higher than anticipated LETRS training and additional data training.
- Addition of Portable Rental costs of \$360,000 for monthly rentals and costs to get them prepared.
- Addition of Vehicle Capital Outlay of \$510,227 for the purchase of two additional buses using the State Transportation grant.
- Addition in Construction in Progress Capital Outlay of \$1,428,768 for early grading and other construction related costs.
- Addition of ERC Fee of \$474,320 for the fee to the firm who filed the ERC credit for us.
- Reduction in New Debt costs of (\$450,000) for anticipated new debt starting in the next fiscal year.

This budget will leave excess revenues over expenditures of \$401,071 leaving and ending fund balance of \$11,254,227, or 36% of annual expenditures.
