# Preface

At Encore, our goal is for English learner students to become competent in areas of comprehension, reading, speaking, and structure of the English language through the integrated use of second language methods and strategies.

# **Identification of Students and Services Offered**

## Home Language Survey

Encore administers a home language survey (HLS) as part of the initial enrollment on the school's enrollment forms. The purpose of the home language survey is to help identify which students are potential ELs and who will require assessment of their English language proficiency (ELP) to determine whether they are eligible for language assistance services.

## **English Language Proficiency Assessment**

All students that are coming to Encore as a new California resident who indicate that their home language is not English will be tested with the Initial English Language Proficiency Assessments for California (ELPAC). The Initial ELPAC has three proficiency levels:

- · Initial Fluent English Proficient
- · Intermediate English Learner
- · Novice English Learner

The ELPAC has two separate assessments:

**Initial Assessment (IA)** - The ELPAC IA identified students as either an English Learner or as fluent in English. The IA is given only one time during a student's tenure within a California public school system and is based on the results of the home language survey. The score given locally is the official IA score. The IA is given to students in grades K-12 when they indicate that English is not the primary language spoken at home.

**Summative Assessment (SA)** - English Learners will subsequently take the ELPAC SA every year until they are reclassified as fluent English proficient. The SA is administered to students that were



previously identified as EL from the IA results. The results of the SA are used as one of four criteria for student reclassification, assigning appropriate EL support, and to report progress of students.

The tests are administered by the English Learner Coordinator that is certificated in administering the ELPAC SA. The ELPAC SA is completed in small groups and one-on-one and is administered within two separate testing sessions.

The IA testing window is year-round. Any student with a primary language at home that is something other than English as determined by the home language survey at enrollment AND has not previously been administered the IA shall be assess for English language proficiency within 30 calendar days after the date of first enrollment in a California public school, or within 60 calendar days before the date of first enrollment, but not before July 1 of that school year. The ELPAC SA testing window lasts four months, commencing February 1 through May 31. The ELPAC SA will be administered to all currently enrolled English Learners to assess progress during the testing window.

Encore will notify all parents of the responsibility for SA testing and of SA results within 30 days of receiving results from the publisher. The SA will be used to fulfill the requirements under the **Every Students Succeeds Act** for annual English proficiency testing.

## **Student Support Curriculum**

## **Students in Levels 1 and 2**

## Junior High:

Students will have individual pull-out support at least once per week for 45 minutes that includes teacher developed curriculum including authentic and other ancillary materials. Students will be enrolled in a weekly ESL class that meets once per week for 90 minutes.

## High School:

Students will be enrolled in an English as a Second Language Class as their primary English class for one full school year.

## All Grades:

Students will use teacher developed plans with standards-based curriculum to acquire Basic Interpersonal and Communication Skills (BICS) and transition to Cognitive Academic Language Proficiency (CALPS)

## All Grades:

Teachers will use instructional technology and SDAIE strategies to deliver content supporting



language learning during all courses within a student's block. Teachers undergo professional development at least twice per year to drive the improvement of English Language Learners academic success.

**English Language Development** - This includes four parts of language: speaking, listening, reading, and writing. Although emphasis is on speaking and listening, the purpose of ELD is to help EL students develop strategies and skills through direct instruction. Designated for Levels 1 and 2 - In junior high, this includes a 90-minute class each week for intense language development. In high school, this includes an English Second Language course embedded into the student block. Effective ELD improves academic success by explicitly focusing on the language. Aligned to CA ELD standards, ELD instruction is research and standards based. It is structured through a scope and sequence of language and provides specific language objectives. This instruction teaches vocabulary, syntax, grammar, discourse, functions, and conventions.

## Students in Levels 3 and 4

Students will have regular individual pull-out support that includes teacher developed curriculum including relevant, standards-based materials and support coaching.

Teachers will use instructional technology and SDAIE strategies to deliver content supporting language learning during all courses within a student's block. Teachers undergo professional development at least twice per year to drive the improvement of English Language Learners academic success.

Students will have access to additional peer and teacher tutoring each week.

**Designated ELD** - is for teachers to intentionally teach English to help build a strong English language foundation. This level of instruction includes interactive activities that are carefully planned and focus on all components of the English language. Students regularly meet each week to complete these lessons.

**Integrated ELD** - All teachers that provide instruction use integrated ELD methodology to provide core content to English learners. For students that are levels 1 - 3, teachers use a variety of strategies to ensure comprehension, including primary language support provided by technology aides. Integrated ELD promotes deeper understanding of the English language and provides access to a broad core of study with standards-based core curriculum using scaffolding.



All English Learners have access to an A-G curriculum. Encore uses research-based methodology to support EL students. All students are evaluated on a regular basis through benchmarks, reviews, and quizzes.

All levels of English Learners will have support tailored to them based on individual development. Classroom teachers will provide differentiated instruction in a general education classroom setting.

The EL Coordinator/Paraprofessional will work with students individually or in small groups so they can gain the language skills to succeed academically.

The English Language Development (ELD) component of the program supports ELs through:

-Qualified staff in second language pedagogy.

- Access and implementation of integrated ELD.

**Use of Integrated ELD strategies** - frontloading vocabulary, chunked reading, graphic organizers, visual aids, guided practice, independent practice, pre-reading strategies, text annotation, minilessons, modifications for assessments, and varying methods to check for understanding.

## Interventions

El students are monitored by the counselor/intern counselor assigned to the EL student caseload. Watching for adequate progress toward acquiring English proficiency and appropriate academic progress are key benchmarks.

All interventions go through the same process:

- 1. Initial meeting with EL Coordinator to discuss teacher/parent concerns.
- 2. An assessment that determines specific area(s) of need.
- 3. A plan of instruction that target needs.
- 4. Progress monitoring by the EL Coordinator.
- 5. Implementation and instruction with multiple opportunities for feedback.

## ELAC

Encore will maintain an English Learner Advisory Committee (ELAC), which will meet regularly during each semester. The meetings will focus on curriculum taught in the school, skills for success, and parent support for college and career readiness. The ELAC also provides input for the annual LCAP.



All EL students have access to teaching staff qualified in second language pedagogy, tutoring, and other academic support programs.

Encore meets all requirements of federal and state law relative to equal access to curriculum for those who are English learners. Encore will adopt the Encore English Learner Master Plan. The goal is to provide high quality curriculum and instructional programs that will support English learners through graduation and college/career readiness.

# **Initial and Annual Parent Notification**

Returning parents are notified annually of their child's ELPAC results and placement in the program prior to school starting each year. New students and parents are notified as soon as the initial testing results have been received.

For a student to qualify as a designated Initial Fluent English Proficient (IFEP), students must score a minimum of 450 on the initial ELPAC.

Notification to parents will include:

- Reason student is identified as EL
- Test results.
- Available services and methods of instruction.
- ELD exit requirements.
- Parents' rights

# Student Progress Monitoring and Reclassification

Students exited from EL status are monitored for four years, to ensure that;

- 1. They have not been prematurely exited;
- 2. Any academic deficits incurred as a result of participating in the EL program have been remedied;
- 3. They are meaningfully participating in the standard program of instruction comparable to their non-EL peers.



Progress is monitored throughout the year by the EL counselor and the EL coordinator.

Overall student growth is measured through the following devices:

- ELPAC scores
- Teacher Evaluation show oral and written samples of student work portfolios
- Benchmark test Scores
- SBAC test scores
- Parent input

The EL counselor and the EL coordinator. review data points four times a year to ensure all English learner students are on track for reclassification.

All programs include English Language Development (ELD) and teaching strategies differentiated for each student's level of English language proficiency. - Structured English Immersion (SEI) Program: Students who score at less than reasonable fluency are placed in an SEI program and are taught overwhelmingly in English. \*\*NOTE: At any time during the school year, you may have your child moved into the English Language Mainstream Program by completing a *Request for English Language Mainstream* form.

Parents/Guardians may choose a language acquisition program that best suits their child. Schools in which the parents or legal guardians of 30 pupils or more per school or the parents or legal guardians of 20 pupils or more in any grade request a language acquisition program that is designed to provide language instruction shall be required to offer such a program to the extent possible. (20 U.S.C. Section 6312[e][3][A][viii][III]); (*EC* Section 310[a])

Parents of English learners have a right to decline or opt their children out of the school district's language acquisition program or opt out of particular English learner service(s) within a language acquisition program. (20 U.S.C Section 6312[e][3][A][viii]) However, LEAs remain obligated to provide the student meaningful instruction (5 CCR Section 11302) until the student is reclassified, inform the parent when progress is not made, and offer the parent programs and services to consider at that time. (5 California Code of Regulations Section 11302)



## **ENGLISH LEARNER (EL) RECLASSIFICATION PROCESS**

## **Reclassification Policy**

Encore Junior & Senior High School for the Arts has adopted a reclassification process to enable students initially identified as English Learners to exit specialized program services and participate without further language assistance as Fluent English Proficient students. English Learners shall be designated as Reclassified Fluent-English Proficient (R-FEP) when they have acquired the English language skills necessary to receive instruction and achieve academic progress in English only, at a level equivalent to students of the same age or grade whose primary language is English.

The reclassification criteria include multiple measures to ensure both proficiency in the English language and participation equal to that of average native speakers in the school's regular instructional program. The reclassification criteria ensures the student's readiness to exit from specialized English Learner programs by demonstrating achievement and mastery of gradeappropriate standards in the following areas:

- 1. English language proficiency, including listening, speaking, reading and writing
- 2. Academic achievement
- 3. Teacher/Parent Consultation

## **Criteria for Reclassification**

- 1. Overall ELPAC score: Level 4
- 2. CAASPP Smarter Balanced Test: Score above "Standard Not Met"
- 3. Grades: "C-" or better in English and social studies courses in one of the last two semesters.
- 4. Overall academic GPA: 2.5 or higher
- 5. Parent approval

## **Steps to Reclassification**

Anyone may recommend a student for reclassification at any time. The counselor will gather appropriate documentation according to the following steps and make a recommendation to the designated administrative staff member based on a review of the student data.

1. The counselor, classroom teacher, or parent, may make a recommendation that a student be evaluated for possible reclassification at any time during the school year.


2. The counselor gathers documentation.

3. The counselor will make arrangements to consult with the parents to review the student's progress and the reclassification criteria. During the meeting, the student's progress will be discussed as well as the recommendation to designate the student to Reclassified Fluent English Proficient (RFEP). If the parent is unable to come to the school, a person speaking the parent's primary language will consult with the parent via telephone or Zoom and document this conversation on the Reclassification Form. An administrator makes the final approval.

4. If a student is reclassified, the student's designation to RFEP will be noted in AERIES, along with the date of reclassification.

5. A reclassified student may be placed in regular courses at the time of reclassification or at the next natural break in instruction (i.e., beginning of the next semester).

6. The student's counselor is responsible for follow-up and monitoring the student's progress.

#### **Monitoring of RFEP Students**

Students who have been reclassified as RFEP receive follow-up monitoring for a minimum of 4 years after reclassification. Each counselor accesses data in the student information system (AERIES) of RFEP students for the purpose of monitoring their subsequent academic progress. Reclassified students having difficulty in the core curriculum will have access to the support services offered at the site to all students who are not meeting standards. Those support services are outlined in the School Site Plan and will be reviewed with parents/guardians at the time of the reclassification consultation.

If the student is not making progress in any academic class, the counselor will meet with the student and may recommend any or all of the following interventions:

-Student/teacher/parent conference

-Tutoring or other academic support program

-Placement in a reading, writing or math support class

-Summer school (when available)

Site administration examines the progress of individual English Learners and Reclassified Fluent English Proficient students annually along with data on the progress of all students as part of the process of evaluating the overall effectiveness of the English Learner program in terms of student learning.

California Education Code section 1240 requires that I annually visit Williams-monitored schools identified in our county and report to you the results of my findings on a quarterly basis (October, January, April, and July). As you may know, Assembly Bill 599 became effective on January 1, 2022, and updated the criteria for schools eligible for monitoring under the Williams Settlement legislation beginning with the 2022/23 school year. Schools, including charter schools, that meet any of the criteria listed below are subject to monitoring this fiscal year:

- Eligible for Comprehensive Support and Improvement or Additional Targeted Support and • Improvement in 2019/20.
- Fifteen percent or more of the school's teachers do not possess a valid and clear or preliminary teaching credential (teacher assignment data based on Census Date - October 2020).

This report includes first quarter findings for the visit to Encore Jr./Sr. High School for the Performing and Visual Arts on 9/1/2022. Let me state at the outset that the visit was a positive, professional experience with a focus by the entire staff on seeking to improve the learning of each student at Encore Jr./Sr. High School for the Performing and Visual Arts.

The purpose of my visit as specified in California Education Code section 1240 was to:

- 1. Determine if students have "sufficient" textbooks or instructional materials in the four core subject areas (English language arts, mathematics, history/social science, science) and, as appropriate, science laboratory equipment in grades 9-12, world languages, and health;
- 2. Determine if there is any facility condition that "poses an emergency or urgent threat to the health or safety of pupils or staff."

The law further requires the county superintendent:

1. Determine if each monitored school has provided accurate data for the annual School Accountability Report Card (SARC) related to sufficiency of instructional materials and the safety, cleanliness, and adequacy of school facilities, including "good repair."

- 2. Annually review teacher misassignments and teacher vacancies for monitored schools; and
- 3. Receive quarterly reports from all school districts in San Bernardino County on complaints filed within the school district concerning insufficient instructional materials, teacher vacancies and misassignments, and emergency or urgent facilities issues under the Uniform Complaint Procedures.

Before proceeding with the report, please see the list of definitions as described by law:

- "Sufficient textbooks or instructional materials" each pupil, including English learners, has a standards-aligned textbook or instructional materials, or both, to use in class and take home. This does not require two sets of textbooks or instructional materials for each pupil. The materials may be in a digital format as long as each pupil, at a minimum, has and can access the same materials in the class and to take home, as all other pupils in the same class or course in the school district. Education Code requires that school districts remedy insufficiencies of instructional materials in the four core subject areas within two months (eight weeks) of the beginning of the school year.
- School facility "emergency or urgent threat" a condition poses a threat to the health or safety of pupils or staff.
- School facility "good repair" the facility is clean, safe, and functional as determined by the Facility Inspection Tool (FIT) developed by the Office of Public School Construction or a local evaluation instrument that meets the same criteria.

In summary, my findings in the four required areas were as follows:

# INTRODUCTION & BACKGROUND

Eide Bailly LLP (hereinafter referred to as "we," "our," or "us") conducted a forensic accounting examination of Encore Junior and Senior High School of the Arts' ("Encore") Associated Student Body ("ASB") financial records from July 1, 2016 through April 30, 2021 ("scope time period").

Encore is a nonprofit charter school that started operating in the Hesperia Unified School District in August of 2008. "The mission of Encore High School is to provide a creative, challenging, and nurturing environment that offers secondary students with innovative preparation for a university education, career pathway, and a pursuit of the arts." In 2015, a Riverside location was added. Each location managed their own ASB funds with a separate bank account. Two years later, Encore was asked to merge the bank accounts, but have the record keeping tracked at each individual site.

In November of 2020, Encore's annual auditors determined that Encore was charging mandatory fees for its clubs and programs. When Encore was informed that this was not allowed, Encore hired an attorney to determine next steps. As a result, it was identified that unallowable pupil fees had been collected for the cheerleading uniforms for at least five years.

Per Education Code 49010, a "Pupil Fee" means a fee, deposit, or other charge imposed on pupils, or a pupil's parents or guardians, in violation of Section 49011 and Section 5 of Article IX of the California Constitution, which require educational activities to be provided free of charge to all pupils without regard to their families' ability or willingness to pay fees or request special waivers, as provided for in Hartzell v. Connell (1984) 35 Cal.3d 899. A pupil fee includes, but is not limited to, all of the following:

 A fee charged to a pupil as a condition for registering for school or classes, or as a condition for participation in a class or an extracurricular activity, regardless of whether the class or activity is elective or compulsory, or is for credit.

- 2. A security deposit, or other payment, that a pupil is required to make to obtain a lock, locker, book, class apparatus, musical instrument, uniform, or other materials or equipment.
- 3. A purchase that a pupil is required to make to obtain materials, supplies, equipment, or uniforms associated with an educational activity.

Encore was then asked by Hesperia Unified School District to have an independent review of Encore's past and present practices and policies regarding pupil fees. The specific request is listed below:

"This review must be conducted by a neutral party (not an advocate or representative of Encore) with sufficient expertise and knowledge in this specific issues and/or their familiarity with CDE's application of the free school requirements when it reviews pupil fees complaint appeals, and result in a neutral report that addresses, among other things, (1) past fees, donations, expenses, etc. charged to or made by students (including but not limited to those noted by the District in the Notice and Staff Analysis) during the 2016-20 Charter term, including a determination based on a preponderance of the evidence standard, whether those items constituted unlawful pupil fees or were permissible donations and/or fees charter schools are authorized to charge (2) issues of recommendations for correcting and eliminating any unlawful fees and best practices."

We were engaged by Encore on May 16<sup>th</sup>, 2021 to determine the dollar amount of reimbursements for purchases that were identified as unallowable pupil fees.

Certain names and related information have been included within this report and accompanying workpapers without being redacted for reporting purposes. Encore should consider redacting this information as deemed necessary prior to any disclosure to third parties.

- Various support documentation for ASB deposits.

# SCOPE LIMITATION

Based on the information provided or observed, we encountered some scope limitations to this engagement. A summary of them is listed below:

- It was noted during the engagement that Encore did not have completed general ledgers for fiscal years FY2017 and FY2018. In addition, the FY2019-FY2021 general ledgers did not provide detailed information regarding the deposits. Therefore, we used the NCR Silver Online system ("NCR") detail for comparison purposes.
- Encore could not locate all support documentation for the Hesperia deposits. The total number of deposits where support documentation could not be found was 104, totaling \$135.841.19 (Workpaper 2).
- Encore could not locate the NCR information or support documentation for the Riverside location for 2 years. We estimate about **\$510,000** of ASB funds could not be examined.

# OBSERVATIONS

The following information reflects our observations to date based on the procedures performed by us with the available financial records for the ASB review for Unallowable Pupil Fees for the scope period.

## A. EXAMINATION OF BANK ACTIVITY

We examined available ASB bank statements and identified a total of **6,752** transactions. We documented **1,805** deposit/credit transactions, totaling **\$2,109,341.70** (**27%** of the transactions) and **4,948** disbursement/debit transactions, totaling **\$2,179,432.96** (**73%** of the transactions). **Figure 1** below is a summary of the deposits/credits by year<sup>1</sup>:

## **B. EXAMINATION OF SUPPORT DOCUMENTATION**

We requested support for each deposit to determine what items were charged. We were provided with the following:

- Student Services Daily Reconciliation Forms
- Student Services Bookkeeping Daily Paid Out Cash Reconciliation Forms
- Item Sales Reports
- Credit Card by Phone Forms
- Employee Pre-Reimbursement Forms
- Copies of checks and credit card receipts
- Copies of the bank deposit slips.

An example of these forms and support information is provided in **EB01-08**.

We examined available support documentation for **1,352** deposits, making us unable to confirm **104** deposits, totaling **\$135,841.19** (Workpaper 2). We have summarized the total deposits we were unable to confirm by year in Figure 3.

We used the California Education Codes, FCMAT ASB Manual, and the FCMAT Help Desk to assist in classifying and estimating the amount of unallowable pupil fees for Encore. Copies of the exact Education Codes and guidelines used are in **EB09-23**.

### **C. EXAMINATION OF ASB ACCOUNTING**

We examined available general ledger detail for the ASB Programs. The FY2017 and FY2018 general ledgers provided were blank and the FY2019-FY2021 general ledgers do not indicate what the deposits were for or the source of funds. As a result, we examined NCR data to further examine the deposits.

We were provided read only access to NCR to obtain information regarding the deposit detail. In the NCR system, we were able to extract the Item Sales Reports and additional information necessary into Excel formats for the scope period (See **EB24** for examples of what was obtained). These excel files were used to help identify the names of the payees and verify the possible unallowable fees. We identified a total of **37,180** transactions, totaling **\$1,324,223 net sales** in NCR. Comparing the NCR net sales Detail to the bank statements, we noted a **\$645,756.16** difference between the two. As was previously stated, **\$135,841.19** of this amount was due to a lack of support for the Hesperia location, leaving **\$509,914.97** unaccounted for. We believe that these were payments made at the Riverside location and Encore had no support or NCR data available that could be provided. Although these scope limitations above were noted, we were able to perform procedures to an estimate of **67%** of the total deposits.

Per our review of NCR, we obtained a list of Item Names, which were the specific charges for the ASB program, within the system and their respective descriptions. This list totaled **390** item names, however we also found the list to be incomplete, as **36** item names did not provide enough detail to determine which program the ASB good or services were for (**Workpaper 3**). In addition, per our review of the FY2017-FY2018 NCR System data, we noted several item names that were not in the fixed NCR list noted above. . To resolve our questions, we interviewed the advisors of each group and the bookkeeper for additional information.

Using the information gathered through interviews, item sales reports, and reviewing the class syllabi for all classes held at the charter school, we calculated the estimate of the Unallowable Pupil Fees to be returned to the providers is **\$53,542.89**. Workpaper **4** is the list of the specific transactions we estimate are Unallowable and the explanation for that determination. **Figure 4** for a summary of the unallowable pupil fees by year.

**Workpaper 5** shows a summary of Unallowable Pupil fees by Item Name, total, and explanation for being Unallowable.

We have prepared a **Workpaper 6** that provides the names and related amounts, which is not included in this report. For privacy reasons, this workpaper can be provided to Encore separately upon request.

### **D. QUESTIONABLE TRANSACTIONS**

In **Workpaper 4**, we also noted two questionable transactions looking at the list: 50/50 Raffle and Unknown.

For the raffles, Encore is a charter school registered under non-profit status. Per CA Penal Code 320.5, a raffle can be conducted if it is by an "eligible organization as defined in subdivision (c) for the purpose of directly supporting beneficial or charitable purposes or financially supporting another private, nonprofit, eligible organization that performs beneficial or charitable purposes if the raffle is conducted in accordance with this section." Subdivision (c) states that "eligible organization" means a private, nonprofit organization that has been qualified to conduct business in California for at least one year prior to conducting a raffle and is exempt from taxation pursuant to Sections 23701a, 23701b, 23701d, 23701e, 23701f, 23701g, 23701k, 23701l, 23701t, or 23701w of the Revenue and Taxation Code." Revenue and Taxation Code 23701d speaks directly to a "corporation, community chest or trust, organized and operated exclusively for religious, charitable, scientific, testing for public safety, literary, or educational purposes, or to foster national or international amateur sports competition (but only if no part of its activities involved the provision of athletic facilities or equipment)." This could be interpreted as the 50/50 raffle being allowable with the entity. However, Penal Code 320.5 also says "any person who receives compensation in connection with the operation of the raffle shall be an employee of the eligible organization that is conducting the raffle, and in no event may compensation be paid from revenues required to be dedicated to beneficial or charitable purposes."<sup>2</sup> Although half of the proceeds are going to the non-profit school, it appears that the other half is going to parents or students, who are not employed with the school. As such, we recommend Encore discuss this issue with their legal counsel, to verify the allowability of these transactions. The total amount of these deposits is **\$468.50**. This balance can be calculated by reviewing Workpaper 4.

The Unknown transactions were due to the inability to obtain enough support to determine the purpose of the charges. These charges were performed at the Riverside site, but the NCR

information could not be obtained by Encore. The support documentation provided showed us that the funds were deposited into the Encore bank account but did not provide us with the item sales report or other information needed to determine the source of deposit. We have included them in the Unallowable Fees to be conservative. The total amount for these deposits is **\$4,757.94**. This balance can be calculated by reviewing Workpaper 4.

## RECOMMENDATIONS

Through our examination, we observed certain internal control weaknesses within Encore. Encore should consider the following recommendations to improve Encore's internal controls.

- Encore's FY2017 and FY2018 general ledgers are missing from their QuickBooks accounting records. It is our recommendation that Encore verify the accuracy and completeness of their general ledgers at the end of each year.
- It was noted through our examination that deposit support documentation was missing and thus we were unable to identify if deposits were for unallowable pupil fees or not for the entire scope period. It is our recommendation to have all support documentation in a secure location and organized for ease of review.
- It was noted through our examination that some reimbursements and purchases were
  paid from collected cash prior to deposit. This increases the risk of unallowable spending.
  We did not examine the disbursements that were being reimbursed to verify if they were
  allowable or not but we did observe that once the cash was used, the remaining cash was
  then deposited back into the ASB bank account. We recommend that payments and
  purchases be made only by valid checks from the ASB account to avoid unallowable ASB
  spending.
- It appears that reconciliations between the NCR system and the general ledger were not being performed monthly. Due to this, there was a difference between the NCR System, General Ledger Detail, and Bank balances. We recommend a reconciliation be done every month to reconcile all three balances and verify all information is accurate and complete.
- It appears through examining the NCR system records, not all the information was properly documented for all transactions. For example, the customer's name was sometimes filled out as "Walk in Customer" or the operator's name. We recommend that all transactions be filled out as complete and accurate as possible.

## CONCLUSION

This forensic accounting report, inclusive of a narrative and workpapers, reflects the procedures performed, documents examined and related observations to date.

Based on our examination from July 1, 2016 through April 30, 2021, we observed the following related to Encore's concerns:

- 1. We calculated Unallowable Pupil Fees = totaling **\$55,461.06**.
- 2. The general ledgers for FY17 and FY18 should be created for accounting completeness and accuracy.
- Monthly reconciliations should be performed to verify the completeness of NCR, QuickBooks, and the bank statements.
- 4. Cash payments are made from undeposited cash receipts. All cash receipts should be deposited and payments made in full and checks for purchases issued.
- 5. Encore should consult with legal counsel to verify if the 50/50 Raffles are allowable.
- 6. Support documentation should be maintained for all deposits for the last four years.

We have <u>not provided an opinion</u> in this report related to any person or party violating applicable laws and regulations. The determination as to whether a person or party has violated applicable laws and regulations is not a decision for us; it is decision for a governing body, judge, or jury.

We were <u>not engaged to perform a financial audit</u>, which the objective would be to express an opinion on the specified elements, accounts, or items. Accordingly, we do not express such an opinion. Had we performed additional procedures, other matters might have come to our attention that would have been reported to Encore.

Our analyses and observations are based upon information provided to us as of the date of this report. It is possible that if additional information is forthcoming, our analyses and observations could be materially different. We reserve the right to amend, modify, and or supplement this

report if deemed necessary due to new information as our examination may continue in this matter.

- Fees for childcare and development services, except that no fees shall be assessed to students enrolled in the program for severely disabled children, as stated in Education Code section 8250(d), or families receiving CalWORKs cash aid (Education Code sections 8350 and 8350.5)
- Fees for state preschool, except that no fees shall be assessed to families of students placed in state preschool by an IEP [Education Code sections 8239, 8250(d) (3), 8263(g), (h), 8265, 56000] or families receiving Cal Works cash (Education Code sections 8350 and 8350.5).
- Fees for supervision of children before and after school, except that no child who desires to participate shall be denied the opportunity to participate because of the inability to pay the fee (Education Code sections 8487 and 8488).

### **Prohibited Fees**

California Education Code section 38118 states, "Writing and drawing paper, pens, inks, blackboard, blackboard erasers, crayons, lead pencils and other necessary supplies for the use of the schools shall be furnished under direction of the governing board of the school districts." The attorney general has issued an opinion that art material for art classes and mechanical drawing sets, cloth for use in dressmaking classes, wood for carpentry classes, gym suits for physical education classes, bluebooks necessary for final examinations, and paper on which to write a theme or report when such a theme or report is a required assignment, are necessary supplies. Therefore, if a school district requires pupils to use any of the prior mentioned items, the school district must provide them without charge so that the pupil can participate in regular classroom work in the particular subject involved. [Ops. Cal Atty. Gen. No. NS-4114 (1942)].

The attorney general's use of the term "school supplies" excludes items or materials that are essential regardless of whether the person is a student. For example, a district is not obligated to furnish corrective lenses and clothes because these items are needed regardless of whether the person is a student.

Public schools can recommend, and even make available, strictly optional materials for the students' personal benefit. The law allows parents, other individuals and school districts to purchase instructional materials from the state-adopted lists (Education Code section 60310). Also, teachers may make available a list of suppliers for tutorials, books, supplemental educational materials, or may sell inexpensive quality paperback literature for leisure reading. Teachers may encourage students to use appropriate study aids as long as these purchases are strictly optional and in no way part of the regular instructional program. Materials are not considered necessary supplies if they are not part of the adopted curriculum or part of an established extracurricular program, and there is no penalty for failure to use or purchase the materials. On the other hand, when such enrichment literature or materials are used as supplemental instructional material for a class or are an established part of an extracurricular activity, it then becomes a necessary supply which must be provided or loaned free of charge. Whether a grade is assigned or not is not the crucial point; it is the participation that counts and whether the material used in the instructional or extracurricular activity becomes a necessary school supply.

The opinions of the attorney general indicate that charges may not be levied for the following [See, e.g., Ops. Cal. Atty. Gen. No. NS 2469 (1940)].

- A security deposit, or other payment, that a pupil is required to make to obtain a lock, locker, book, class apparatus, musical instrument, uniform, or other materials or equipment. The law does allow the district to charge students for lost or damaged school property after the fact, but not before the issuance and loss.
- A deposit to guarantee that the district will be reimbursed for loss to the district in case of breakage, damage to, or loss of school property.
- An admission charge to an exhibit, fair, theater or similar activity for instruction or extracurricular purposes when a visit to such places is part of the district's educational program.

- A fee charged to a pupil as a condition for enrolling or registering for school, class or course of instruction, or as a condition for participation in a class or an extracurricular activity, regardless of whether the class or activity is elective or compulsory, or is for credit. This includes fees or tuition for attendance in a summer or vacation school, a registration fee, a fee for a catalog of courses, a fee for an examination in a subject, a late registration or program change fee, a fee for the issuance of a diploma or certificate, or a charge for lodging.
- Membership fees in a student body or any student organization as a condition for enrollment or participation in athletic or other curricular or extracurricular activities sponsored by the school (ASB cards may be sold to allow discounts or free entrance to games and social events, but not in order to join athletics or other curricular activities).
- Fees to enroll and/or participate in activities of career technical student organizations which are part of a career technical class or course of instruction offered for credit (Education Code section 52375).
- Fees for transportation associated with activities of career technical student organizations which are part of a career technical class or course of instruction offered for credit when those activities are integral to helping the pupil achieve the career objectives of the class or course (Education Code section 52373).
  - The exception to this is when the transportation is between the regular full-time day schools the pupil would attend and the regular full-time occupational training classes they attend that are provided by a regional occupational center or program (Education Code section 39807.5).
- Charges for textbooks and workbooks, except for classes for adults (Education Code sections 60070 and 60410).
- Charging an apprentice or their parents or guardian for admission or attendance in any class, pursuant to section 3074 of the Labor Code (Education Code section 48053).
- A purchase that a pupil is required to make to obtain materials, supplies, equipment, or uniforms associated with an educational activity [Education Code section 49010(b) (2)].
  - Charging for school supplies, materials and equipment needed to participate in educational activities (including classes).
  - Charging for mandated standardized gym suits for physical education classes. A student's grade cannot be affected by not wearing the standardized clothes when the failure to wear the standardized clothes is beyond the student's control [Education Code section 49066(c)].
- Fees to enroll and/or participate in activities of career technical student organizations which are part of a career technical class or course of instruction offered for credit. This section shall apply to activities which occur both during and outside of the regular school day (Education Code section 52375).
- Fees to process an interdistrict transfer request from a pupil residing in another district [Ops. Cal. Atty. Gen. No. 04-501 (2004)].
- Reimbursement for lost average daily attendance (ADA) revenue for absences from school [Ops. Cal. Atty. Gen. No. 96-1004 (1997)]. The original opinion referred to ADA lost for unexcused absences only. Since then, the law has changed such that ADA cannot be earned for unexcused or excused absences [EC Section 48205(d), amended by Cal. Stats. 1999, c. 312 (S.B. 1208), Section 1]. Presumably the previous opinion likewise applies to ADA lost because of excused absences.

On April 20, 1984, the *Hartzell vs. Connell* California Supreme Court decision raised serious questions about the imposition of nonstatutory fees for extracurricular activities. The lead opinion on this matter is that fees may be charged for activities that are recreational and optional, but not for those that are educational.

Because extracurricular activities are described in the opinion as an integral component of public education, they are a part of the educational program and thus must be free. The court further stated,

[The] imposition of fees as a precondition for participation in nonstatutory educational programs offered by public high school districts on a noncredit basis violates the free school guarantee. The constitutional defect in such fees can neither be corrected by providing waivers to indigent students nor justified by pleading financial hardship.

It is also the opinion of the CDE and the *Hartzell vs. Connell* decision that a school district may not charge a fee or require students to purchase necessary materials even if the district maintains a special fund to assist students with financial need or waives such a fee or charge for students with financial need, because the fee or charge remains a condition for all other students not being assisted financially. A fee waiver policy for any students, including those deemed needy, does not make the fee permissible [Hartzell v. Connell, 35 Cal. 3d 899, 912-913 (1984)]. Requiring low-income students and their families to apply for a waiver is considered discriminatory. The requirement to fill out a waiver discourages many students from attempting to enroll in a class because they are embarrassed to ask for a waiver, but also do not want to put their family in financial distress.

A district cannot require students to purchase or pay for a cap and gown as a condition of participation in a graduation ceremony, because the California Supreme Court has found that the high school graduation ceremony is "an integral part of the educational process" because it recognizes cumulative academic achievement. Because the graduation ceremony is an educational activity, pursuant to Education Code section 49010(a), a pupil fee cannot be charged. Education Code section 38119 only authorizes districts to rent caps and gowns from a supplier and provide them free of charge to students. Therefore, a cap and gown fee is not "otherwise allowed by law" per Education Code section 49011(a). The CDE has recommended that a district that requires students to wear a cap and gown at the ceremony inform students that: (1) the district will provide caps and gowns for graduating seniors for use during the ceremony, and (2) students also have the option to purchase an appropriate cap and gown from a vendor. No student should be required to self-identify as indigent in order to receive a cap and gown from the district.

Regarding gym or physical education clothes, Education Code section 49066(c) states, "No grade of a pupil participating in a physical education class may be adversely affected due to the fact that the pupil does not wear standardized physical education apparel where the failure to wear such apparel arises from circumstances beyond the control of the pupil," such as lack of sufficient funds. The California Department of Education has stated the position that a school district may require students to purchase their own gym clothes of a district-specified design and color so long as the design and color are of a type sold for general wear outside of school. Once the required gym uniforms become specialized in terms of logos, school name or other similar characteristics not found on clothing for general use outside of school, they are considered school supplies and the district must provide them free of charge.

Education Code section 49011(b)(4) bars a school district or school, including a charter school, from requiring parents to perform volunteer hours as a condition of allowing their child admission, enrollment, continued enrollment, sibling preference, attendance, participation in education activities or receipt of credit or privileges related to educational activities. Although Education Code section 49011(c) allows school districts, schools and charter schools to request that parents volunteer a specific number of hours per school year, and to identify the benefits to the school district or school because of these volunteer services, such requests may not be coercive or imply negative consequences to a student or parent who does not volunteer.

The subject of fees, deposits and other charges is complicated and can attract increased attention, especially when state funding declines and school agencies try to generate additional revenues. School agencies considering any type of fee not specifically authorized by statute should ask whether it relates to an activity that is an integral component of public education. If the agency is not sure whether a specific fee should be

charged, it should obtain a legal opinion on the matter as this is likely much less costly than a lawsuit against the district because of illegal fees.

FCMAT strongly recommends that school districts, county offices of education and charter schools take the following steps to ensure compliance with pupil fee laws:

- 1. Review the CDE's fiscal management advisory guidance.
- 2. Provide additional training to administrators, teachers and staff to ensure compliance with pupil fee laws.
- 3. Remind teachers to update websites and course syllabi to ensure compliance with pupil fee laws.
- 4. Remind athletic coaches and other extracurricular activity advisors to update policies, websites and written handouts to ensure compliance with pupil fee laws.

### **Charter Schools**

Education Code section 47605(d) prohibits a charter school from charging tuition, but does not mention fees or other charges. Although charter schools are exempt from most laws governing school districts per Education Code section 47610, the California Constitution cannot be rendered inapplicable by the Legislature. Therefore, the California constitution's guarantee of a free public education (Article IX, Section 5) also applies to charter schools. In 2012, AB 1575 made it clear that the prohibition on pupil fees applies to charter schools [Education Code sections 49010(a) and 49011(d)].

Charter schools may only charge those fees specifically authorized in Education Code sections that have been made applicable to charter schools. For example, charter schools can charge fees for food and field trips because those Education Code sections apply to charter schools [Education Code section 35330(d) (field trips); Education Code section 49430.7(a) (2) (food)]. However, charter schools cannot charge the "other fees authorized by law" that districts can, except for fees related to activities that are not an integral component of public education.

# What fees, if any, can be charged to students?

Question: The high school and the middle schools are currently charging the student fees listed below.

\$10 Science Lab Fees

\$40 Cooking class fees

\$20 Ceramics, Jewelry, Arts, and Wood shop fees

\$45 Choir class

\$25 Band class

AP exam fees (unknown at this time)

These lab fees provide funding for disposable, consumable materials used in each class. Students are allowed (and encouraged) to take home whatever they make/test/produce in their classes. Science teachers feel that the science lab fees should be treated as a shop fee so that lab fees can be charged just like home economic, jewelry, and wood shop class in accordance with Ed Code section 17551.

But some teachers think the students should not take any bio-hazardous waste home because of the safety reason.

In 1992, the board approved the science fees. It is not included in the board policy but an approval was noted in board minutes. The teachers now understand the free school guarantee because I have shared the Fiscal Management Advisory 97-02 but they still feel that they have an approval to charge certain fees from the board. I don't see any additional funding to offset the current student lab fees but I also don't want any lawsuit from parents.

### Please advise.

**Response:** The California Constitution provides for a free school system. Since 1874, the California Supreme Court has interpreted this to mean that this entitles students to be educated at the public's expense. Title 5, California Code of Regulations, section 350, specifically states:

"A pupil enrolled in a school shall not be required to pay any fee, deposit, or other charge not specifically authorized by law."

The State Board of Education has reiterated that no fees are to be charged except where specifically authorized by law. This understanding is based on the authority in Article IX, Section 5 of the California Constitution. The Attorney General has also made it clear in many of their opinions that school districts cannot levy fees as a condition for participation in any class, whether elective or compulsory. Such unallowable fees include security deposits for locks, lockers, books, class apparatus, musical instruments, uniforms or other equipment. Clearly, students may not be charged fees for participation in either curricular or extracurricular activities. And, whenever a particular curriculum or extra curricular program is adopted, all supplies, both necessary and supplemental, must be provided free of charge by the district.

The district cannot establish a two tier educational system by defining some minimum educational standard as the requirement and then tell students that "there is also a second, higher standard which you can strive for, if you pay for rent, or provide some specified additional supplies which the school does not provide."

The Education Code specifically authorizes certain fees which are not forbidden by the Code of Regulations Title 5 prohibition. The following fees can be levied as authorized in the following Education Code Sections:

• Transportation to and from school as it is a non-educational activity. Education Code section 39807.5

o Fees for transportation for extra curricular activities are not legal as it is an integral part of some of these activities. If participation in an extra curricular activity requires transportation and if the school district provides it, it may not collect fees for it.

o By law, school districts must exempt from transportation charges pupils of parents and guardians who are indigent as set forth in rules and regulations adopted by the board. Furthermore, no charge shall be made for the transportation of disabled students.

o The sum of state aid received for home to school transportation and the parent fees collected may not exceed actual operating cost of home to school transportation for each fiscal year. Education Code section 39809.5

Transportation of pupils to places of summer employment. Education Code section 39837

• Charges for food served to pupils. Education Code sections 38082 (formally 39872), and 38084 (formally 39874)

· Sale of materials purchased from the incidental expense account to pupils in classes for adults if provided in the governing board regulations. The proceeds of all such sales shall be deposited in that account. Education code section 52615

· Class materials can be sold to persons enrolled in adult classes. This may include materials necessary for making of articles by students enrolled in adult education. The materials shall be sold at no less than the cost to the district. Any article made is then the property of the person who made it. Education code sections 52612, 52615 and 17552

· Charges can be imposed for textbooks used in adult classes or a refundable deposit can be imposed on loaned books. Education code section 60410

· Insurance for field trips. School districts must provide, or make available, medical or hospital insurance for pupils participating on any excursion or field trip, and the cost incurred by the school district "may be paid from the funds of the district, or by the insured pupil or his or her parent or guardian." Education Code section 35331

· Lost or damaged books or other district supplies. If students fail to return school property loaned to the pupil, or willfully cut, deface or otherwise injure school property, the parent or guardian is liable for all damages not to exceed \$10,000. Education Code section 48904

> o When the minor and parent are unable to pay for the damages or to return the property, the school district or private school shall provide a program of voluntary work for the minor in lieu of payment of monetary damages.

• Fees for adult school classes. Education Code section 52612.

o No fees are allowed for English and citizenship for foreigners, classes in elementary subjects, and classes for which high school credit is granted when taken by a person holding a high school diploma.

o Adults may be charged a fee but high school students may not, even though they may be enrolled in the same class.

o Adults may be charged for all or part of the costs of transportation. Education Code section 39801.5.

• Tuition fees charged to pupils whose parents are actual and legal residents of an adjacent foreign country or an adjacent state. Education Code sections 48050, 48051 and 48502

· Apprentices shall not be charged fees of any kind in any district providing instruction under Section

3074 of the Labor Code. Education Code section 48053.

 $\cdot$  Materials can be sold to a student for property the student has fabricated from such materials for their own use as long as the price does not exceed direct cost of the materials used and provided that the school district governing board has authorized such sales pursuant to an adopted board policy. This applies to classes such as wood shop or sewing where an item is taken home by the students, but not when the items remain at school. It also does not apply to food in home economic classes which is eaten as part of the course work. Education Code section 17551.

o This section does not authorize a blanket general fee to cover multiple items nor does it mean an obligation to purchase the item. This section must be read together with the constitutional free school guarantee and the statutes requiring schools to provide necessary school supplies and instructional materials. Whenever students fabricate products in a class such as wood shop or sewing, the wood or cloth for such products must be furnished free of charge. If the student decides to take a particular item home, then the law authorizes the district to sell that item to the student for the cost of the materials. If the student does not want to take an item home, then the district would keep the item and cannot charge or otherwise penalize the student.

o The school district is recommended to have board adopted policies and guidelines which specify the conditions for implementing this section, keeping in mind the free school guarantee.

 $\cdot$  Fees for an optional fingerprinting program for kindergarten or other newly enrolled students can be assessed to the parent or guardian who chooses to participate. The fee cannot exceed the actual costs associated with the program. Education Code section 32390.

• Students may be charged fees for community classes in civic, vocational, literacy, health, homemaking, and technical and general education, not to exceed the cost of maintaining the community classes. Governing boards may expend from the district's general fund any money that is budgeted for community services to establish and maintain community service classes. Education Code sections 51810 and 51815

o These community classes may be held at any time during the school year as determined by the governing board. Education Code section 51812

o Community courses are not intended to teach required courses that K-12 students must complete as part of their instructional programs. They usually include classes in music, drama, art, handicraft, science, literature, nature studdy, nature contacting, aquatic sports, athletic and other such classes of general interest to the community. These classes are primarily intended for adults and are only open to minors who the governing board believes would profit from such classes.

o Community service classes cannot be used as K-12 summer school, except for the incidental attendance of students with special interest in the subjects being taught.

o Schools are lawfully authorized to charge fees for community service classes. But, in order to charge a fee for driver's training, schools must design their driver training programs to be community service and not for the benefit of high school students. (This principal would apply to any type of community service class.) Education Code sections 51815 and Driving School Association vs. San Mateo School Districts. 11 Cal App 4th (1992), and California Association for Safety Education vs. Brown 30 Cal. App 4th (1994)

• Fees for several statutory child care programs under certain conditions, while precluding charges to children's families whose children are enrolled in the state preschool program or for services to severely handicapped children. A similar before and after school child supervision program is authorized to charge fees to participants as long as "no needy child who desires to participate shall be denied the opportunity to participate because of inability to pay the fee". Education Code sections 8263(f), 8250(d), 8265, 8487, 8488(b)

 $\cdot$  Actual cost of duplication of public records or student records. The California Public Records Act authorizes public agencies to charge direct costs of duplication for its records. The direct cost of duplication standard also applies to reproductions of the prospectus of school curriculum. Education Code section 49091.14

o Direct costs of duplication phrase allows a local agency to recover only the actual cost of copying documents and does not include ancillary tasks associated with the retrieval, inspection and handling of the file from which the copy is extracted. North County Parents Organization et al vs. Department of Education 23 Cal App4th (1994)

o School districts must specify the cost, if any, which will be charged to the parent for reproducing copies of records in a parental notice upon enrollment and in the annual notification of parents of their rights required by the Education Code 48980. Education Code 49063(h)

 $\cdot$  Charges for medical and accident insurance for athletic team members who can afford to pay. All members of the athletic team must have such insurance. Education Code section 32221.

o Whenever the school board determines that a team member or parent or guardian are financially unable to pay the costs of insurance protection, then the governing board shall require the costs of the protection to be paid either out of funds of the district or the student body.

• Fees for field trips and excursions may be charged in connection with courses of instruction or school related social, educational, cultural, athletic, or school band activities. But, no pupil shall be prevented from making the field trip or excursion because of lack of sufficient funds. Education Code section 35330.

o The governing board shall coordinate efforts of the community service groups to supply funds for pupils in need of them.

o No student may be left behind due to insufficient funds, nor may a student be left behind for failing or refusing to participate in fund-raisers.

 $\cdot$  Fees for outdoor science camp programs. The fee cannot be mandatory - no pupil shall be denied the opportunity to participate in a school camp program because of nonpayment of the fee. Education code section 35335

o No student may be left behind due to insufficient funds, nor may a student be left behind for failing or refusing to participate in fund-raisers.

California law provides "Writing and drawing paper, pens, inks, blackboards, blackboard erasers, crayons, lead pencils and other necessary supplies for the use of the schools shall be furnished under direction of the governing boards of the school districts" (Education Code section 38118). Based on this section, the Attorney General has concluded that materials and mechanical drawing sets for art classes, cloth for dressmaking classes, wood for carpentry classes, gym suits and shoes for physical education classes, bluebooks necessary for examinations, and paper on which to write a theme or report when such a theme or report is a required assignment must be furnished by school district without charge as necessary supplies. Such supplies appear to be supplies that must be available to students in order to participate in regular classroom work in the particular subjects involved. The State Department of Education supports this view. The general rule as stated by the Attorney General is that "supplies must be furnished free of cost to students when the supplies are what might be termed school supplies and are necessary in order for the students to pursue a course of study". So rather than state what materials a school district is not obligated to furnish, the Attorney General limits the discussion to the question above.

The Attorney General's use of term school supplies does exclude those items or materials that are essential regardless of whether or not the person is a student. For example, a district is not obligated to furnish corrective lenses and clothes as these items are needed whether or not the person is a student.

Also, since school districts are required to furnish necessary supplies, they are also responsible for regular upkeep and maintenance of those supplies. Attempts to impose an unconditional obligation on pupils to maintain and repair school district equipment are too broad. to a pupil where he or she willfully cuts, defaces, or otherwise injures the property as a result of pupil misconduct. This law allows the district to impose requirements for proper care and usage and consequent liability for mishandling, but not liability where damage may result from normal wear and tear, or from an intervening cause or a third party.

Districts can recommend, and even make available, strictly optional materials for the students' personal benefit. The law allows parents or other individuals as well as school districts to directly purchase instructional materials from the state adopted lists (Education Code section 60310). Also, teachers may make available a list of suppliers for tutorials, books, supplemental educational materials, or sell inexpensive quality paperback literature for leisure reading. Teachers may encourage students to use appropriate study aids as long as these purchases are strictly optional and in no way part of the regular instructional program. If such things are not part of the adopted curriculum or part of an established extracurricular program, and there is no penalty for failure to use or purchase these materials, such materials are not necessary supplies. The opposite arises, though, when such enrichment literature or materials are used as supplemental instructional material for a class or is an established part of an extracurricular activity as it then becomes a necessary supply which must be provided or loaned free of charge. Its not whether or not a grade is assigned that is the crucial point. It is the participation that counts and whether or not the material used in the instructional or extracurricular activity becomes a necessary school supply.

Basically, the opinions of the Attorney General indicate that charges may not be levied for the following:

 $\cdot$  A deposit in the nature of a guarantee that the district would be reimbursed for loss to the district on account of breakage, damage to, or loss of school property

 $\cdot$  An admission charge to an exhibit, fair, theater or similar activity for instruction or extracurricular purposes when a visit to such places is part of the district's educational program

 $\cdot$  A tuition fee or charge as a condition to enrollment in any class or course of instruction, including a fee for attendance in a summer or vacation school, a registration fee, a fee for a catalog of courses, a fee for an examination in a subject, a late registration or program change fee, a fee for the issuance of a diploma or certificate, or a charge for lodging.

 $\cdot$  Membership fees in a student body or any student organization as a condition for enrollment or participation in athletic or other curricular or extracurricular activities sponsored by the school (ASB cards may be sold to allow discounts or free entrance to games and social events).

 $\cdot$  Instructional materials must be furnished without charge to elementary and high school students. Adults may be assessed a charge for books not to exceed their true cost to the district. Education Code sections 60070 and 60410.

 $\cdot$  Fees to enroll and/or participate in activities of career technical student organizations which are part of a career technical class or course or instruction offered for credit. Education Code section 52375.

• Pupils shall not be charged for transportation associated with activities of career technical student organizations which are part of a career technical class or course of instruction offered for credit when those activities are integral to assisting the pupil to achieve the career objectives of the class or course. Education Code section 52373

o The exception to this is when the transportation is between the regular full time day schools that they would attend and the regular full time occupational training classes attended by them as provided by a regional occupational center or program. Education Code section 39807.5.

In specific answer to your question, FCMAT is not able to provide legal advice, but since you are worried about the current charges, review the information we have provided above and see how the current charges that are occurring line up with the above information. And, if you have concerns about what is truly legal or not legal after reviewing the above, you should check with your legal counsel. Although staff is mentioning Education Code section 17551, this section does not allow for fees to be charged up front...basically this code section means that all students can make the items regardless of paying fees or material charges, but at the end of the year if they want to bring the items home the district can charge for the actual cost of materials in making the item. This code does not authorize the class fees up front as all students are entitled to make the same items, whether or not they have money to do so.

Also, remember that board policy can be stricter than the law, but the law takes precedence over board policy if they are in disagreement. Again, this is why you should get your legal counsel involved.

EDUCATION CODE

Section 48932

48932. The governing board of any school district may authorize any organization composed entirely of pupils attending the schools of the district to maintain such activities, including fund-raising activities, as may be approved by the governing board.

The governing board of any school district may, by resolution, authorize any student body organization to conduct fund-raising activities on school property during school hours provided that the governing board has determined that such activities will not interfere with the normal conduct of the schools.

(Enacted by Stats. 1976, Ch. 1010.)

Section 35330

35330. (a) The governing board of a school district or the county superintendent of schools of a county may:

(1) Conduct field trips or excursions in connection with courses of instruction or school-related social, educational, cultural, athletic, or school band activities to and from places in the state, any other state, the District of Columbia, or a foreign country for pupils enrolled in elementary or secondary schools. A field trip or excursion to and from a foreign country may be permitted to familiarize pupils with the language, history, geography, natural sciences, and other studies relative to the district's course of study for pupils.

(2) Engage instructors, supervisors, and other personnel to contribute their services over and above the normal period for which they are employed by the district, if necessary, and provide equipment and supplies for the field trip or excursion.

(3) Transport by use of district equipment, contract to provide transportation, or arrange transportation by the use of other equipment, of pupils, instructors, supervisors, or other personnel to and from places in the state, another state, the District of Columbia, or a foreign country where those excursions and field trips are being conducted, provided that, when district equipment is used, the governing board shall secure liability insurance, and if travel is to and from a foreign country, liability insurance shall be secured from a carrier licensed to transact insurance business in the foreign country.

(4) Provide supervision of pupils involved in field trips or excursions by certificated employees of the district.

(b) (1) A pupil shall not be prevented from making the field trip or excursion because of lack of sufficient funds. To this end, the governing board shall coordinate efforts of community service groups to supply funds for pupils in need.

(2) A group shall not be authorized to take a field trip or excursion authorized by this section if a pupil who is a member of an identifiable group will be excluded from participation in the field trip or excursion because of lack of sufficient funds.

(c) (1) The attendance or participation of a pupil in a field trip or excursion authorized by this section shall be considered attendance for the purpose of crediting attendance for apportionments from the State School Fund in the fiscal year. Credited attendance resulting from a field trip or excursion shall be limited to the amount of attendance that would have accrued had the pupils not been engaged in the field trip or excursion.

(2) Credited attendance shall not exceed 10 schooldays except in the case of pupils participating in a field trip or excursion in connection with courses of instruction, or

school-related educational activities, and that are not social, cultural, athletic, or school band activities.

(d) All persons making the field trip or excursion shall be deemed to have waived all claims against the district, a charter school, or the State of California for injury, accident, illness, or death occurring during or by reason of the field trip or excursion. All adults taking out-of-state field trips or excursions and all parents or guardians of pupils taking out-of-state field trips or excursions shall sign a statement waiving all claims.

(e) Transportation allowances shall not be made by the Superintendent for expenses incurred with respect to field trips or excursions that have an out-of-state destination. A school district that transports pupils, teachers, or other employees of the school district in schoolbuses within the state and to destinations within the state, pursuant to the provisions of this section, shall report to the Superintendent on forms prescribed by him or her the total mileage of schoolbuses used in connection with educational excursions. In computing the allowance to a school district for regular transportation there shall be deducted from that allowance an amount equal to the depreciation of schoolbuses used for the transportation in accordance with rules and regulations adopted by the Superintendent.

38082. Food shall not be sold at any cafeteria operated by a school district to anyone except pupils and employees of any school district, members of the governing board thereof, and members or employees of the fund or association maintaining the cafeteria; provided, however, that nothing herein contained shall prohibit the use of the cafeteria facilities by any work or harvest camp maintained by or within the district, and by persons entitled to use the school under the Civic Center Act; and provided further, that the governing board of any school district operating a cafeteria may exempt by formal resolution of the board other individuals and organizations from the operation of this section including senior citizens participating in any program conducted pursuant to Chapter 6 (commencing with Section 9500) of Division 8.5 of the Welfare and Institutions Code.

Section 38084

38084. The food served shall be sold to the patrons of the cafeterias at such a price as will pay the cost of maintaining the cafeterias, exclusive of the costs made a charge against the funds of the school district by this chapter, and items made a charge against the funds of the school district by resolution of the governing board under authority of this chapter.

PENAL CODE

Section 320.5

320.5. (a) Nothing in this chapter applies to any raffle conducted by an eligible organization as defined in subdivision (c) for the purpose of directly supporting beneficial or charitable purposes or financially supporting another private, nonprofit, eligible organization that performs beneficial or charitable purposes if the raffle is conducted in accordance with this section.

(b) For purposes of this section, "raffle" means a scheme for the distribution of prizes by chance among persons who have paid money for paper tickets that provide the opportunity to win these prizes, where all of the following are true:

(1) Each ticket is sold with a detachable coupon or stub, and both the ticket and its associated coupon or stub are marked with a unique and matching identifier.

(2) Winners of the prizes are determined by draw from among the coupons or stubs described in paragraph (1) that have been detached from all tickets sold for entry in the draw.

(3) The draw is conducted in California under the supervision of a natural person who is 18 years of age or older.

(4) (A) At least 90 percent of the gross receipts generated from the sale of raffle tickets for any given draw are used by the eligible organization conducting the raffle to benefit or provide support for beneficial or charitable purposes, or it may use those revenues to benefit another private, nonprofit organization, provided that an organization receiving these funds is itself an eligible organization as defined in subdivision (c). As used in this section, "beneficial purposes" excludes purposes that are intended to benefit officers, directors, or members, as defined by Section 5056 of the Corporations Code, of the eligible organization. In no event shall funds raised by raffles conducted pursuant to this section be used to fund any beneficial, charitable, or other purpose outside of California. This section does not preclude an eligible organization from using funds from sources other than the sale of raffle tickets to pay for the administration or other costs of conducting a raffle.

(B) An employee of an eligible organization who is a direct seller of raffle tickets shall not be treated as an employee for purposes of workers' compensation under Section 3351 of the Labor Code if the following conditions are satisfied:

(i) Substantially all of the remuneration (whether or not paid in cash) for the performance of the service of selling raffle tickets is directly related to sales rather than to the number of hours worked.

(ii) The services performed by the person are performed pursuant to a written contract between the seller and the eligible organization and the contract provides

that the person will not be treated as an employee with respect to the selling of raffle tickets for workers' compensation purposes.

(C) For purposes of this section, employees selling raffle tickets shall be deemed to be direct sellers as described in Section 650 of the Unemployment Insurance Code as long as they meet the requirements of that section.

(c) For purposes of this section, "eligible organization" means a private, nonprofit organization that has been qualified to conduct business in California for at least one year prior to conducting a raffle and is exempt from taxation pursuant to Sections 23701a, 23701b, 23701d, 23701e, 23701f, 23701g, 23701k, 23701l, 23701t, or 23701w of the Revenue and Taxation Code.

(d) Any person who receives compensation in connection with the operation of the raffle shall be an employee of the eligible organization that is conducting the raffle, and in no event may compensation be paid from revenues required to be dedicated to beneficial or charitable purposes.

(e) No raffle otherwise permitted under this section may be conducted by means of, or otherwise utilize, any gaming machine, apparatus, or device, whether or not that machine, apparatus, or device meets the definition of slot machine contained in Section 330a, 330b, or 330.1.

(f) (1) No raffle otherwise permitted under this section may be conducted, nor may tickets for a raffle be sold, within an operating satellite wagering facility or racetrack inclosure licensed pursuant to the Horse Racing Law (Chapter 4 (commencing with Section 19400) of Division 8 of the Business and Professions Code) or within a gambling establishment licensed pursuant to the Gambling Control Act (Chapter 5 (commencing with Section 19800) of Division 8 of the Business and Professions Code).

(2) A raffle may not be operated or conducted in any manner over the Internet, nor may raffle tickets be sold, traded, or redeemed over the Internet. For purposes of this paragraph, an eligible organization shall not be deemed to operate or conduct a raffle over the Internet, or sell raffle tickets over the Internet, if the eligible organization advertises its raffle on the Internet or permits others to do so. Information that may be conveyed on an Internet Web site pursuant to this paragraph includes, but is not limited to, all of the following:

(A) Lists, descriptions, photographs, or videos of the raffle prizes.

(B) Lists of the prize winners.

- (C) The rules of the raffle.
- (D) Frequently asked questions and their answers.

(E) Raffle entry forms, which may be downloaded from the Internet Web site for manual completion by raffle ticket purchasers, but shall not be submitted to the eligible organization through the Internet.

(F) Raffle contact information, including the eligible organization's name, address, telephone number, facsimile number, or e-mail address.

(g) No individual, corporation, partnership, or other legal entity shall hold a financial interest in the conduct of a raffle, except the eligible organization that is itself authorized to conduct that raffle, and any private, nonprofit, eligible organizations

receiving financial support from that charitable organization pursuant to subdivisions (a) and (b).

(h) (1) An eligible organization may not conduct a raffle authorized under this section, unless it registers annually with the Department of Justice. The department shall furnish a registration form via the Internet or upon request to eligible nonprofit organizations. The department shall, by regulation, collect only the information necessary to carry out the provisions of this section on this form. This information shall include, but is not limited to, the following:

(A) The name and address of the eligible organization.

(B) The federal tax identification number, the corporate number issued by the Secretary of State, the organization number issued by the Franchise Tax Board, or the California charitable trust identification number of the eligible organization.

(C) The name and title of a responsible fiduciary of the organization.

(2) The department may require an eligible organization to pay an annual registration fee of ten dollars (\$10) to cover the actual costs of the department to administer and enforce this section. The department may, by regulation, adjust the annual registration fee as needed to ensure that revenues willfully offset, but do not exceed, the actual costs incurred by the department pursuant to this section. The fee shall be deposited by the department into the General Fund.

(3) The department shall receive General Fund moneys for the costs incurred pursuant to this section subject to an appropriation by the Legislature.

(4) The department shall adopt regulations necessary to effectuate this section, including emergency regulations, pursuant to the Administrative Procedure Act (Chapter 3.5 (commencing with Section 11340) of Part 1 of Division 3 of Title 2 of the Government Code).

(5) The department shall maintain an automated database of all registrants. Each local law enforcement agency shall notify the department of any arrests or investigation that may result in an administrative or criminal action against a registrant. The department may audit the records and other documents of a registrant to ensure compliance with this section.

(6) Once registered, an eligible organization must file annually thereafter with the department a report that includes the following:

(A) The aggregate gross receipts from the operation of raffles.

(B) The aggregate direct costs incurred by the eligible organization from the operation of raffles.

(C) The charitable or beneficial purposes for which proceeds of the raffles were used, or identify the eligible recipient organization to which proceeds were directed, and the amount of those proceeds.

(7) The department shall annually furnish to registrants a form to collect this information.

(8) The registration and reporting provisions of this section do not apply to any religious corporation sole or other religious corporation or organization that holds property for religious purposes, to a cemetery corporation regulated under Chapter 19 of Division 3 of the Business and Professions Code, or to any committee as defined

in Section 82013 that is required to and does file any statement pursuant to the provisions of Article 2 (commencing with Section 84200) of Chapter 4 of Title 9, or to a charitable corporation organized and operated primarily as a religious organization, educational institution, hospital, or a health care service plan licensed pursuant to Section 1349 of the Health and Safety Code.

(i) The department may take legal action against a registrant if it determines that the registrant has violated this section or any regulation adopted pursuant to this section, or that the registrant has engaged in any conduct that is not in the best interests of the public's health, safety, or general welfare. Any action taken pursuant to this subdivision does not prohibit the commencement of an administrative or criminal action by the Attorney General, a district attorney, city attorney, or county counsel.

(j) Each action and hearing conducted to deny, revoke, or suspend a registry, or other administrative action taken against a registrant shall be conducted pursuant to the Administrative Procedure Act (Chapters 4.5 (commencing with Section 11400) and 5 (commencing with Section 11500) of Part 1 of Division 3 of Title 2 of the Government Code). The department may seek recovery of the costs incurred in investigating or prosecuting an action against a registrant or applicant in accordance with those procedures specified in Section 125.3 of the Business and Professions Code. A proceeding conducted under this subdivision is subject to judicial review pursuant to Section 1094.5 of the Code of Civil Procedure.

(k) The Department of Justice shall conduct a study and report to the Legislature by December 31, 2003, on the impact of this section on raffle practices in California. Specifically, the study shall include, but not be limited to, information on whether the number of raffles has increased, the amount of money raised through raffles and whether this amount has increased, whether there are consumer complaints, and whether there is increased fraud in the operation of raffles.

(*l*) This section shall become operative on July 1, 2001.

(m) A raffle shall be exempt from this section if it satisfies all of the following requirements:

(1) It involves a general and indiscriminate distribution of the tickets.

(2) The tickets are offered on the same terms and conditions as the tickets for which a donation is given.

(3) The scheme does not require any of the participants to pay for a chance to win. (Amended by Stats. 2009, Ch. 38, Sec. 1. (SB 200) Effective January 1, 2010.)

PENAL CODE

Section 326.5

326.5. (a) Neither the prohibition on gambling in this chapter nor in Chapter 10 (commencing with Section 330) applies to any bingo game that is conducted in a city, county, or city and county pursuant to an ordinance enacted under Section 19 of Article IV of the State Constitution, if the ordinance allows games to be conducted only in accordance with this section and only by organizations exempted from the payment of the bank and corporation tax by Sections 23701a, 23701b, 23701d, 23701e, 23701f, 23701g, 23701k, 23701w, and 23701l of the Revenue and Taxation Code and by mobilehome park associations, senior citizens organizations, and charitable organizations affiliated with a school district; and if the receipts of those games are used only for charitable purposes.

(b) It is a misdemeanor for any person to receive or pay a profit, wage, or salary from any bingo game authorized by Section 19 of Article IV of the State Constitution. Security personnel employed by the organization conducting the bingo game may be paid from the revenues of bingo games, as provided in subdivisions (j) and (k).

(c) A violation of subdivision (b) shall be punishable by a fine not to exceed ten thousand dollars (\$10,000), which fine is deposited in the general fund of the city, county, or city and county that enacted the ordinance authorizing the bingo game. A violation of any provision of this section, other than subdivision (b), is a misdemeanor.

(d) The city, county, or city and county that enacted the ordinance authorizing the bingo game may bring an action to enjoin a violation of this section.

(e) Minors shall not be allowed to participate in any bingo game.

(f) An organization authorized to conduct bingo games pursuant to subdivision (a) shall conduct a bingo game only on property owned or leased by it, or property whose use is donated to the organization, and which property is used by that organization for an office or for performance of the purposes for which the organization is organized. Nothing in this subdivision shall be construed to require that the property owned or leased by, or whose use is donated to, the organization be used or leased exclusively by, or donated exclusively to, that organization.

(g) All bingo games shall be open to the public, not just to the members of the authorized organization.

(h) A bingo game shall be operated and staffed only by members of the authorized organization that organized it. Those members shall not receive a profit, wage, or salary from any bingo game. Only the organization authorized to conduct a bingo game shall operate such a game, or participate in the promotion, supervision, or any other phase of a bingo game. This subdivision does not preclude the employment of

security personnel who are not members of the authorized organization at a bingo game by the organization conducting the game.

(i) Any individual, corporation, partnership, or other legal entity, except the organization authorized to conduct a bingo game, shall not hold a financial interest in the conduct of a bingo game.

(j) With respect to organizations exempt from payment of the bank and corporation tax by Section 23701d of the Revenue and Taxation Code, all profits derived from a bingo game shall be kept in a special fund or account and shall not be commingled with any other fund or account. Those profits shall be used only for charitable purposes.

(k) With respect to other organizations authorized to conduct bingo games pursuant to this section, all proceeds derived from a bingo game shall be kept in a special fund or account and shall not be commingled with any other fund or account. Proceeds are the receipts of bingo games conducted by organizations not within subdivision (j). Those proceeds shall be used only for charitable purposes, except as follows:

(1) The proceeds may be used for prizes.

(2) (A) Except as provided in subparagraph (B), a portion of the proceeds, not to exceed 20 percent of the proceeds before the deduction for prizes, or two thousand dollars (\$2,000) per month, whichever is less, may be used for the rental of property and for overhead, including the purchase of bingo equipment, administrative expenses, security equipment, and security personnel.

(B) For the purposes of bingo games conducted by the Lake Elsinore Elks Lodge, a portion of the proceeds, not to exceed 20 percent of the proceeds before the deduction for prizes, or three thousand dollars (\$3,000) per month, whichever is less, may be used for the rental of property and for overhead, including the purchase of bingo equipment, administrative expenses, security equipment, and security personnel. Any amount of the proceeds that is additional to that permitted under subparagraph (A), up to one thousand dollars (\$1,000), shall be used for the purpose of financing the rebuilding of the facility and the replacement of equipment that was destroyed by fire in 2007. The exception to subparagraph (A) that is provided by this subparagraph shall remain in effect only until the cost of rebuilding the facility is repaid, or January 1, 2019, whichever occurs first.

(3) The proceeds may be used to pay license fees.

(4) A city, county, or city and county that enacts an ordinance permitting bingo games may specify in the ordinance that if the monthly gross receipts from bingo games of an organization within this subdivision exceed five thousand dollars (\$5,000), a minimum percentage of the proceeds shall be used only for charitable purposes not relating to the conducting of bingo games and that the balance shall be used for prizes, rental of property, overhead, administrative expenses, and payment of license fees. The amount of proceeds used for rental of property, overhead, and administrative expenses is subject to the limitations specified in paragraph (2).

(l) (1) A city, county, or city and county may impose a license fee on each organization that it authorizes to conduct bingo games. The fee, whether for the initial license or renewal, shall not exceed fifty dollars (\$50) annually, except as provided

in paragraph (2). If an application for a license is denied, one-half of any license fee paid shall be refunded to the organization.

(2) In lieu of the license fee permitted under paragraph (1), a city, county, or city and county may impose a license fee of fifty dollars (\$50) paid upon application. If an application for a license is denied, one-half of the application fee shall be refunded to the organization. An additional fee for law enforcement and public safety costs incurred by the city, county, or city and county that are directly related to bingo activities may be imposed and shall be collected monthly by the city, county, or city and county issuing the license; however, the fee shall not exceed the actual costs incurred in providing the service.

(m) A person shall not be allowed to participate in a bingo game, unless the person is physically present at the time and place where the bingo game is being conducted.

(n) The total value of prizes available to be awarded during the conduct of any bingo games shall not exceed five hundred dollars (\$500) in cash or kind, or both, for each separate game which is held.

(o) As used in this section, "bingo" means a game of chance in which prizes are awarded on the basis of designated numbers or symbols that are marked or covered by the player on a tangible card in the player's possession and that conform to numbers or symbols, selected at random and announced by a live caller. Notwithstanding Section 330c, as used in this section, the game of bingo includes tangible cards having numbers or symbols that are concealed and preprinted in a manner providing for distribution of prizes. Electronics or video displays shall not be used in connection with the game of bingo, except in connection with the caller's drawing of numbers or symbols and the public display of that drawing, and except as provided in subdivision (p). The winning cards shall not be known prior to the game by any person participating in the playing or operation of the bingo game. All preprinted cards shall bear the legend, "for sale or use only in a bingo game authorized under California law and pursuant to local ordinance." Only a covered or marked tangible card possessed by a player and presented to an attendant may be used to claim a prize. It is the intention of the Legislature that bingo as defined in this subdivision applies exclusively to this section and shall not be applied in the construction or enforcement of any other provision of law.

(p) (1) Players who are physically present at a bingo game may use hand-held, portable card-minding devices, as described in this subdivision, to assist in monitoring the numbers or symbols announced by a live caller as those numbers or symbols are called in a live game. Card-minding devices may not be used in connection with any game where a bingo card may be sold or distributed after the start of the ball draw for that game. A card-minding device shall do all of the following:

(A) Be capable of storing in the memory of the device bingo faces of tangible cards purchased by a player.

(B) Provide a means for bingo players to input manually each individual number or symbol announced by a live caller.

(C) Compare the numbers or symbols entered by the player to the bingo faces previously stored in the memory of the device.

(D) Identify winning bingo patterns that exist on the stored bingo faces.

(2) A card-minding device shall perform no functions involving the play of the game other than those described in paragraph (1). Card-minding devices shall not do any of the following:

(A) Be capable of accepting or dispensing any coins, currency, or other representative of value or on which value has been encoded.

(B) Be capable of monitoring any bingo card face other than the faces of the tangible bingo card or cards purchased by the player for that game.

(C) Display or represent the game result through any means, including, but not limited to, video or mechanical reels or other slot machine or casino game themes, other than highlighting the winning numbers or symbols marked or covered on the tangible bingo cards or giving an audio alert that the player's card has a prize-winning pattern.

(D) Determine the outcome of any game or be physically or electronically connected to any component that determines the outcome of a game or to any other bingo equipment, including, but not limited to, the ball call station, or to any other card-minding device. No other player-operated or player-activated electronic or electromechanical device or equipment is permitted to be used in connection with a bingo game.

(3) (A) A card-minding device shall be approved in advance by the department as meeting the requirements of this section and any additional requirements stated in regulations adopted by the department. Any proposed material change to the device, including any change to the software used by the device, shall be submitted to the department and approved by the department prior to implementation.

(B) In accordance with Chapter 5 (commencing with Section 19800) of Division 8 of the Business and Professions Code, the commission shall establish reasonable criteria for, and require the licensure of, any person that directly or indirectly manufactures, distributes, supplies, vends, leases, or otherwise provides card-minding devices or other supplies, equipment, or services related to card-minding devices designed for use in the playing of bingo games by any nonprofit organization.

(C) A person or entity that supplies or services any card-minding device shall meet all licensing requirements established by the commission in regulations.

(4) The costs of any testing, certification, license, or determination required by this subdivision shall be borne by the person or entity seeking it.

(5) On and after January 1, 2010, the Department of Justice may inspect all card-minding devices at any time without notice, and may immediately prohibit the use of any device that does not comply with the requirements established by the department in regulations. The Department of Justice may at any time, without notice, impound any device the use of which has been prohibited by the commission.

(6) The Department of Justice shall issue regulations to implement the requirements of this subdivision, and the California Gambling Control Commission may issue regulations regarding the means by which the operator of a bingo game, as required by applicable law, may offer assistance to a player with disabilities in order to enable that player to participate in a bingo game, provided that the means of providing that

assistance shall not be through any electronic, electromechanical, or other device or equipment that accepts the insertion of any coin, currency, token, credit card, or other means of transmitting value, and does not constitute or is not a part of a system that constitutes a video lottery terminal, slot machine, or device prohibited by Chapter 10 (commencing with Section 330).

(7) The following definitions apply for purposes of this subdivision:

(A) "Commission" means the California Gambling Control Commission.

(B) "Department" means the Department of Justice.

(C) "Person" includes a natural person, corporation, limited liability company, partnership, trust, joint venture, association, or any other business organization.

#### **REVENUE AND TAXATION CODE**

Section 23701d

23701d. (a) A corporation, community chest or trust, organized and operated exclusively for religious, charitable, scientific, testing for public safety, literary, or educational purposes, or to foster national or international amateur sports competition (but only if no part of its activities involved the provision of athletic facilities or equipment), or for the prevention of cruelty to children or animals, no part of the net earnings of which inures to the benefit of any private shareholder or individual, no substantial part of the activities of which is carrying on propaganda or otherwise attempting to influence legislation (except as otherwise provided in Section 23704.5), and which does not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of (or in opposition to) any candidate for public office. An organization is not organized exclusively for exempt purposes listed above unless its assets are irrevocably dedicated to one or more purposes listed in this section. Dedication of assets requires that in the event of dissolution of an organization or the impossibility of performing the specific organizational purposes the assets would continue to be devoted to exempt purposes. Assets shall be deemed irrevocably dedicated to exempt purposes if the articles of organization provide that upon dissolution the assets will be distributed to an organization which is exempt under this section or Section 501(c)(3) of the Internal Revenue Code or to the federal government, or to a state or local government for public purposes; or by a provision in the articles of organization, satisfactory to the Franchise Tax Board; that the property will be distributed in trust for exempt purposes; or by establishing that the assets are irrevocably dedicated to exempt purposes by operation of law. The irrevocable dedication requirement shall not be a sole basis for revocation of an exempt determination made by the Franchise Tax Board prior to the effective date of this amendment.

(b) (1) In the case of a qualified amateur sports organization—

(A) The requirement of subdivision (a) that no part of its activities involves the provision of athletic facilities or equipment shall not apply.

(B) That organization shall not fail to meet the requirements of subdivision (a) merely because its membership is local or regional in nature.

(2) For purposes of this subdivision, "qualified amateur sports organization" means any organization organized and operated exclusively to foster national or international amateur sports competition if that organization is also organized and operated primarily to conduct national or international competition in sports or to support and develop amateur athletes for national or international competition in sports.
